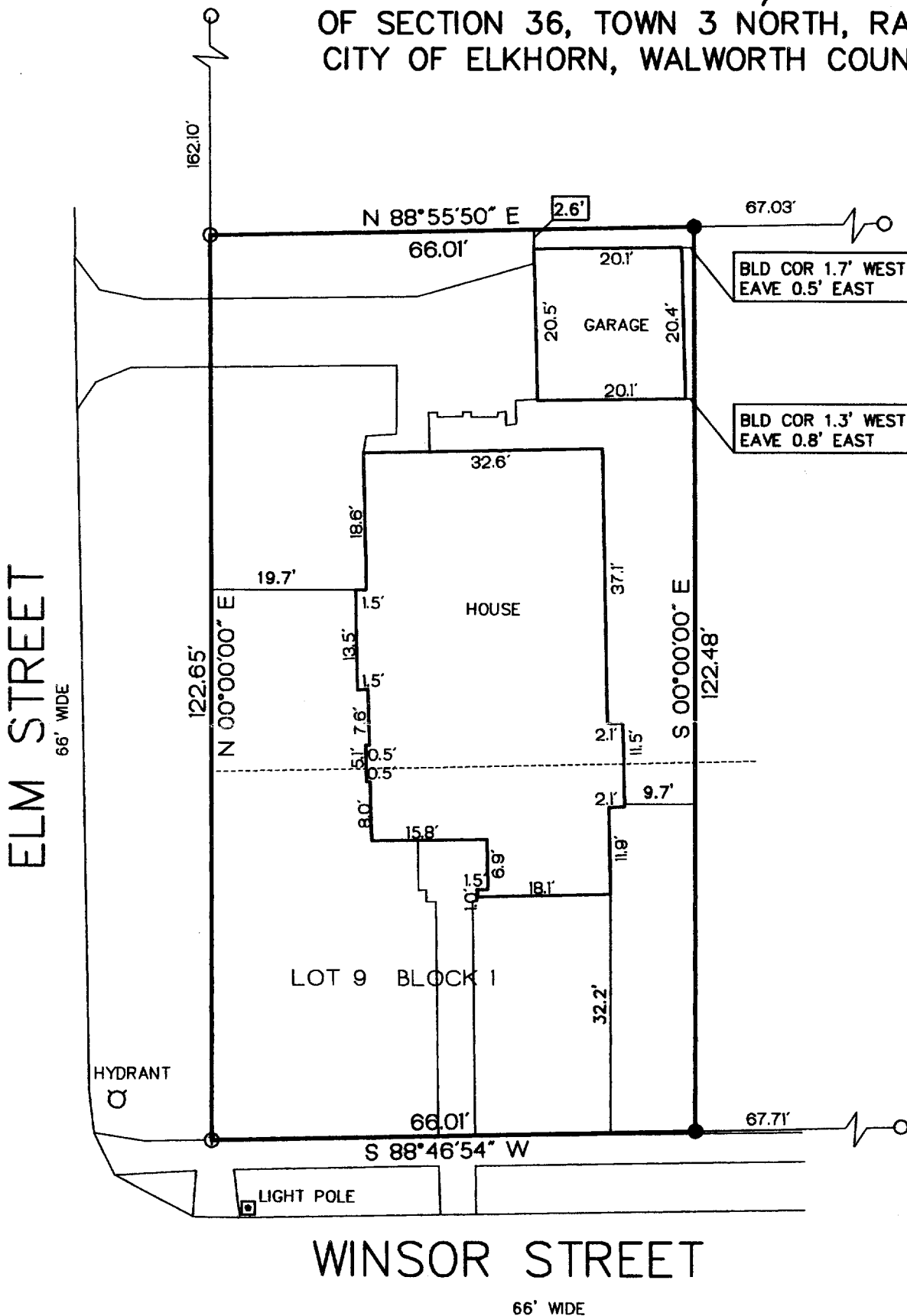

CITY OF ELKHORN, WALWORTH COUNTY, WISCONSIN

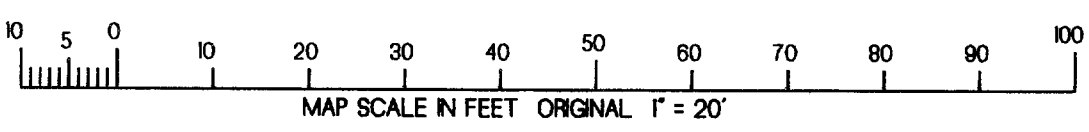


- = FOUND IRON PIPE STAKE

- ⊕ = SET CHISLED "T" IN CONCRETE

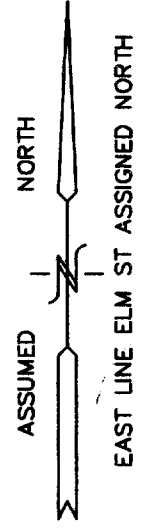
Parcel A: The West 66' of Lot 9, Block 1 of the Ridgeway-Martin Addition to the City of Elkhorn.

Parcel B:

Whisler, run thence northerly along the westerly line of lands formerly owned by said Whisler 16 rods 23 links, thence due West 8 rods to the southeast corner of land now owned by Murphy, which corner is a place of beginning; run thence due North in the West line of Elm Street in the City of Elkhorn in said County; thence due South in a line parallel to and 66 feet distant from the West line of said Murphy's land (said line being the East line of said Elm Street) 72 feet to a point 66 feet due West of the said southwest corner of said Murphy's land; thence due East 66 feet to the place of beginning.

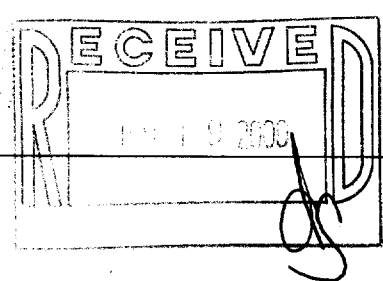
