LEGAL DESCRIPTION:

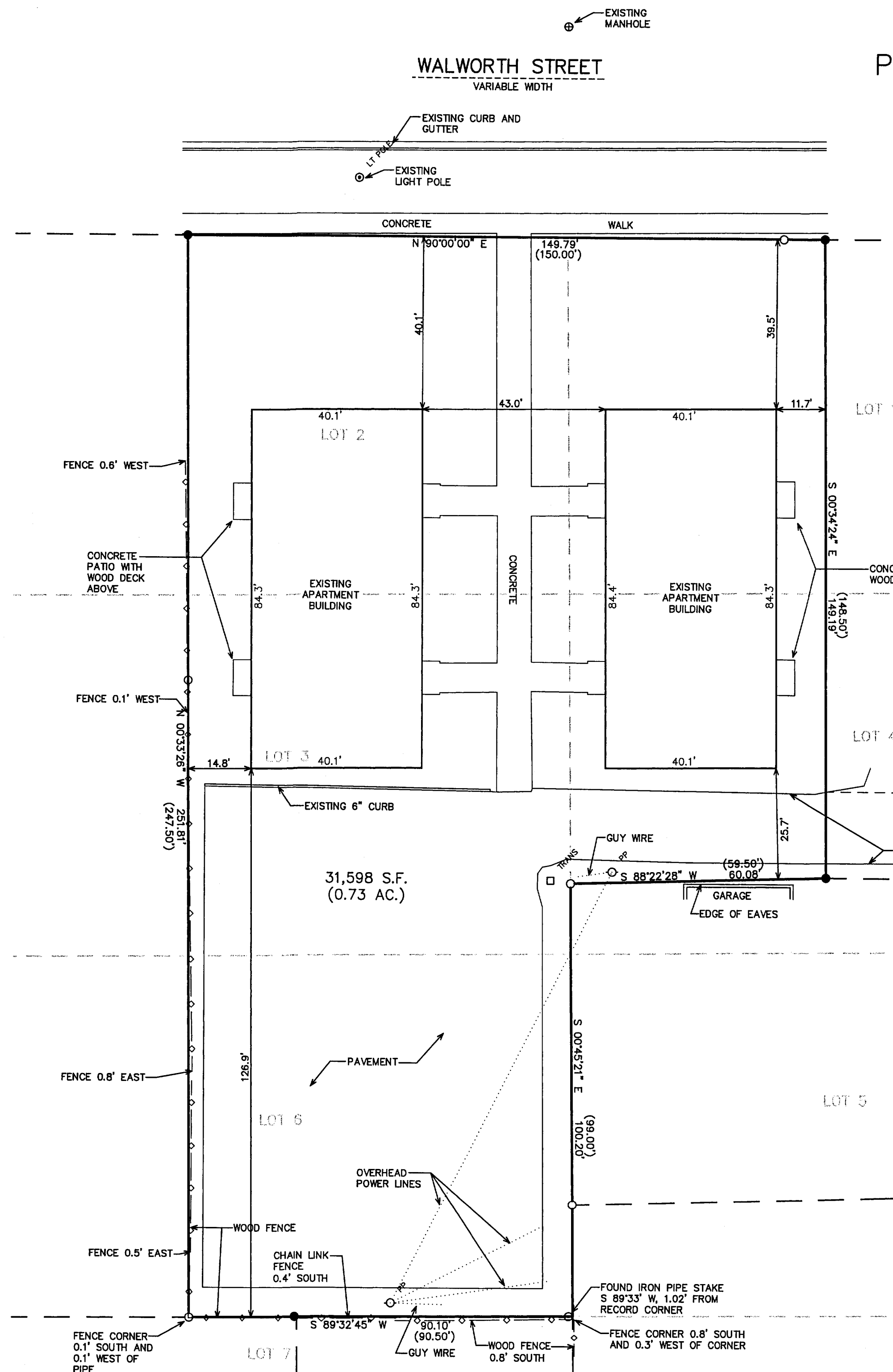
Commencing at a point in the North line of Block 28 of the Original Plat that is 72.50 feet West of the Northeast corner of Block 28 of the original plat of the City of Elkhorn, Walworth County, Wisconsin; thence West along the North line of said Block 28, 150.00 feet; to a point that is 43.02 feet East of the Northwest corner of Lot 2 in said Block; running thence South parallel to the East line of said Block, 15 rods (247.50 feet) to a point on the South line of Lot 6 of said Block 28 (said point being 43.48 feet East of the Southwest corner of said Lot 6) running thence East on the South line of said Lot 6 to the Southeast corner of said Lot 6, running thence North on the East line of Lots 6 and 3 of said Block to a point 66.00 feet South of the North line of Lot 4 in said Block; thence running East parallel with the North line of said Block 3 rods and 10.00 feet, (59.50 feet) to a point that is 72.50 feet West of the East line of said Block, running thence North to the place of beginning, also an easement for ingress and egress on, along and across the South 20.00 feet of the North 66.00 feet to the East 72.50 feet of Lot 4 Block 28 of the Original Plat of the City of Elkhorn, Walworth County, Wisconsin.
