

TAX PARCEL YUNE 00020A

LOCATED IN THE SOUTHWEST 1/4 OF SECTION 31, TOWN 3 NORTH, RANGE 17 EAST, CITY OF ELKHORN, WALWORTH COUNTY, WISCONSIN

Legal Description:

A parcel of land located in the Southwest 1/4 of Section 31, Town 3 North, Range 17 East, in the City of Elkhorn, County of Walworth, State of Wisconsin, described as follows: Commencing at a point that is 763.7 feet South of and 271 feet East of the Northeast corner of Rockwell's Addition to the Village (now City) of Elkhorn, thence South 22° East 100 feet to an iron stake, South 73° West 106.75 feet to an iron stake, the place beginning of this description, thence South 73° West 106.75 feet to an iron stake, thence South 39° 48' East 327 feet to the point in the centerline of the State Trunk Highway known as the Elkhorn-Burlington Road, thence Northeasterly in the centerline of said highway 62.5 feet to a point, thence North 25° 02' West 267.03 feet to the place of beginning.

ALSO, a parcel of land 6 feet in width located in the Southwest 1/4 of Section 31, Town 3 North, Range 17 East, City of Elkhorn, Walworth County, Wisconsin, described as follows: Commencing at an iron pipe stake found marking a point 763.7 feet South and 271 feet East of the Northwest corner of Rockwell's Addition to the City of Elkhorn; thence South 23° 38' 47" East 100.00 feet; thence South 73° 00' 00" West 213.50 feet to an iron pipe stake; thence South 42° 02' 21" East, 202.84 feet to the point of beginning; thence continue South 42° 02' 21" East, 87.00 feet to an iron pipe stake found lying on the Northerly right of way line of State Trunk Highway "11"; thence along said right of way, South 42° 10' 26" West, 6.03 feet; thence North 42° 02' 21" West, 87.00 feet; thence North 42° 10' 26" East, 6.03 feet to the point of beginning.
