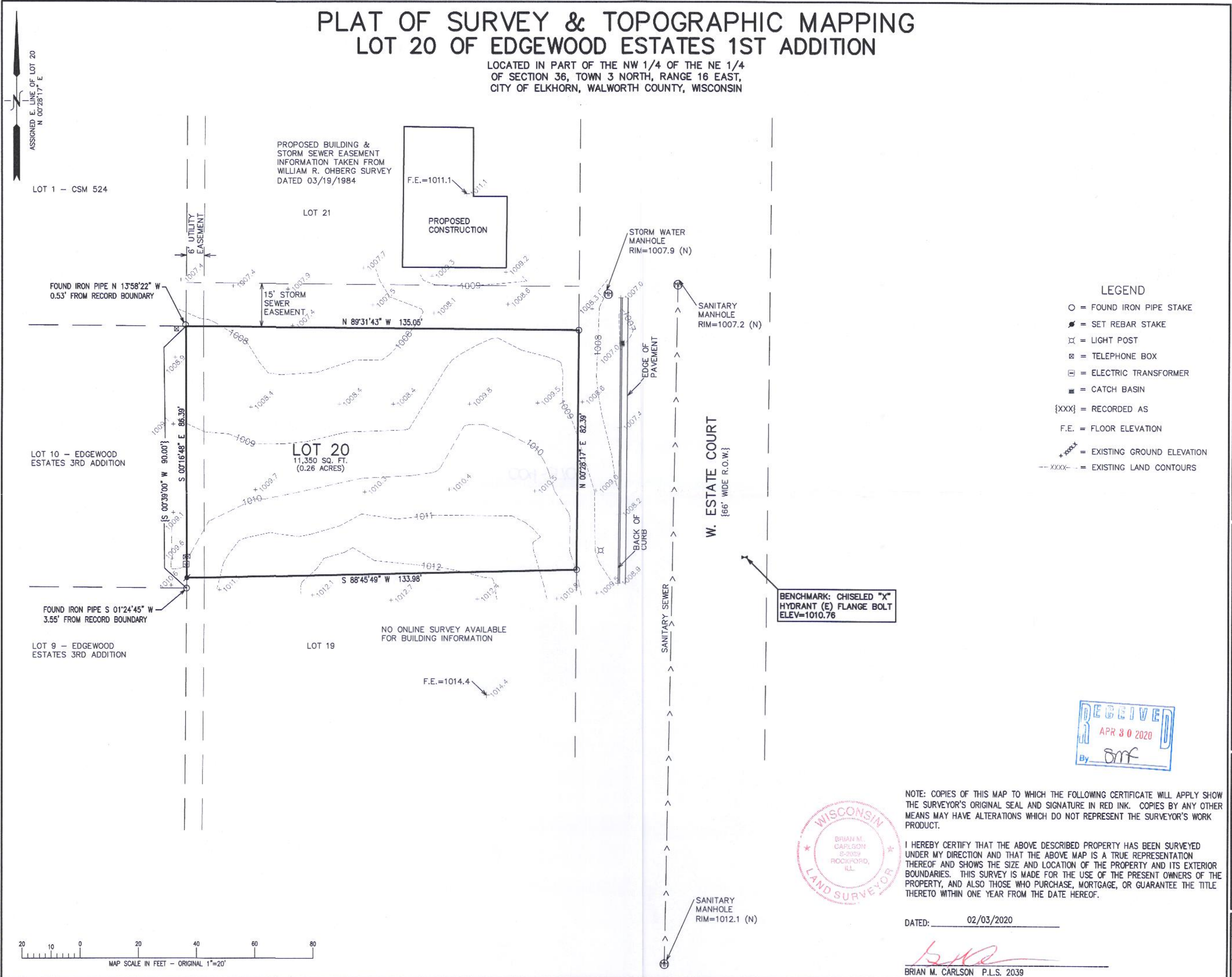


PLAT OF SURVEY & TOPOGRAPHIC MAPPING LOT 20 OF EDGEWOOD ESTATES 1ST ADDITION
