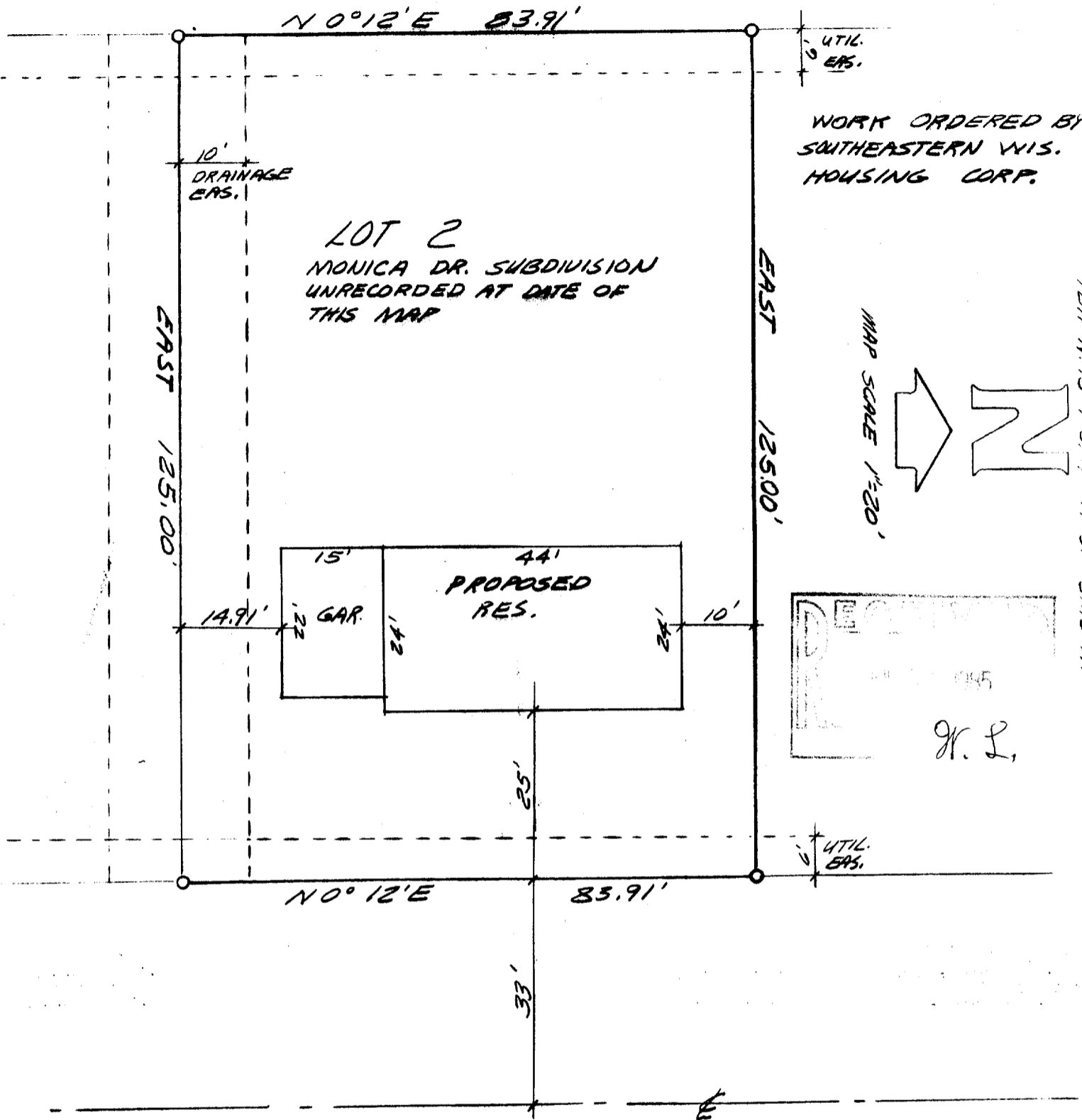
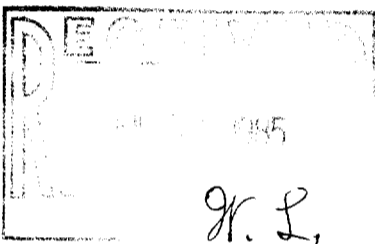


PLAT OF SURVEY OF LOT 2 OF PROPOSED

 WALWORTH COUNTY WISCONSIN



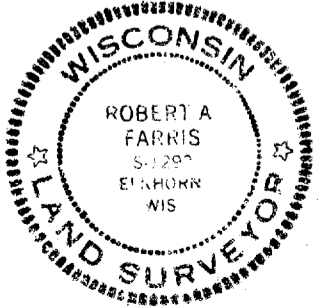

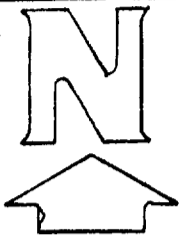
