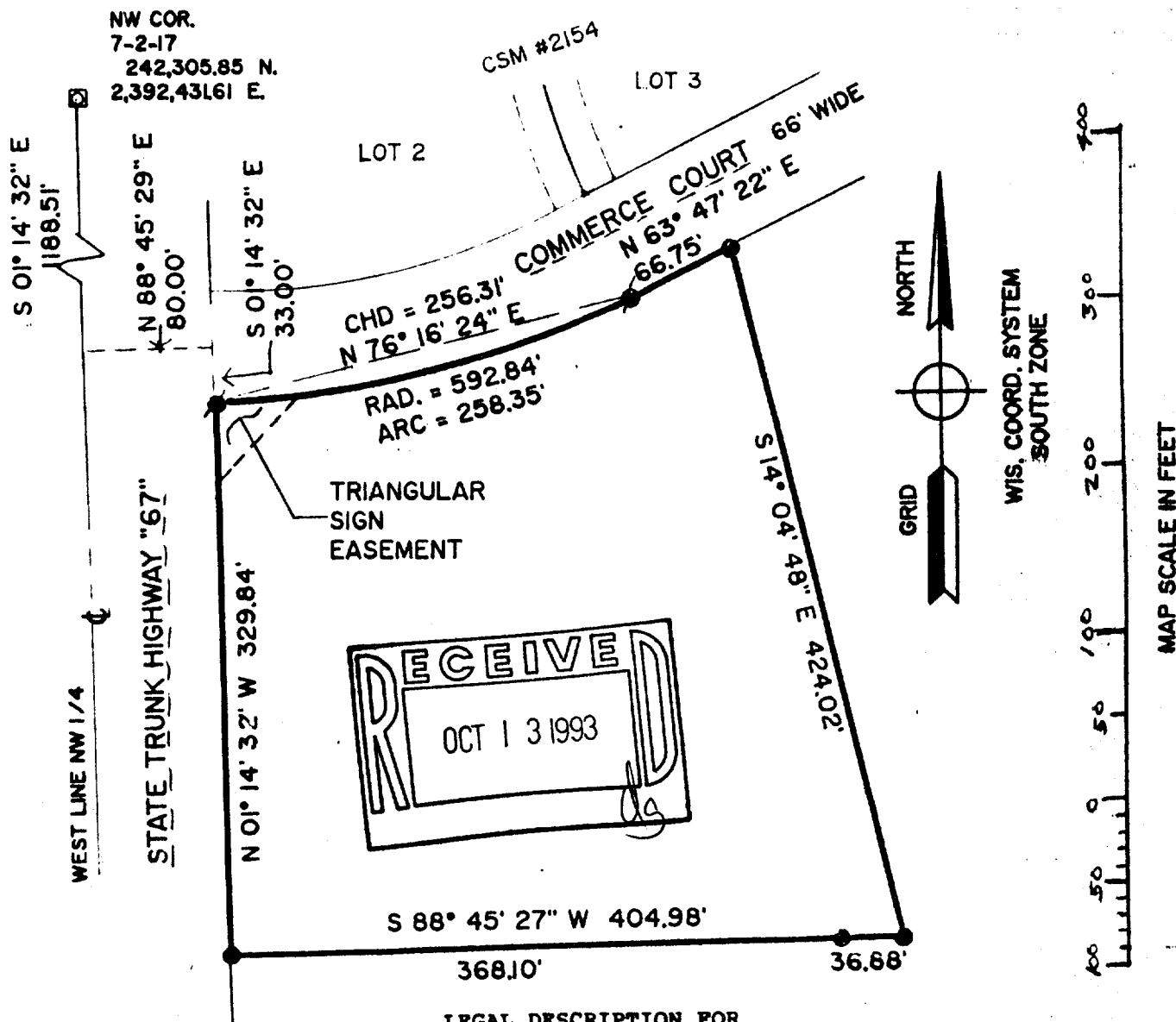

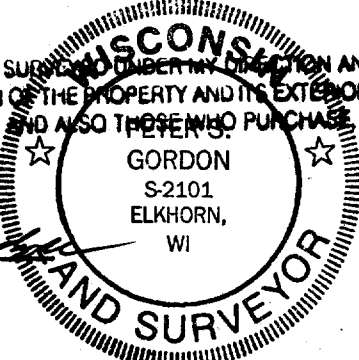
A PARCEL OF LAND LOCATED IN PART OF THE NORTHWEST 1/4 OF THE NORTHWEST 1/4 OF SECTION 7, TOWN 2 NORTH, RANGE 17 EAST, WALWORTH COUNTY, WISCONSIN DESCRIBED AS FOLLOWS: COMMENCING AT A CONCRETE MONUMENT FOUND MARKING THE NORTHWEST CORNER OF SAID SECTION 7; THENCE S 01DEG 14MIN 32SEC E, 1188.51 FEET ALONG THE WEST LINE OF SAID NORTHWEST 1/4; THENCE N 88DEG 45MIN 29SEC E, 80.00 FEET TO THE EASTERLY RIGHT OF WAY OF STATE TRUNK HIGHWAY 67 AND THE CENTERLINE OF COMMERCE COURT; THENCE S 01DEG 14MIN 32SEC E, 33.00 FEET ALONG SAID S.T.H. 67, TO THE SOUTHERLY RIGHT OF WAY OF SAID COMMERCE COURT AND THE POINT OF BEGINNING; THENCE ALONG THE SOUTHERLY RIGHT OF WAY OF SAID COMMERCE COURT, 258.35 FEET ALONG THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS OF 592.84 FEET AND A CHORD WHICH BEARS N 76DEG 16MIN 24SEC E, 256.31 FEET; THENCE CONTINUE ALONG SAID COMMERCE COURT, N 63DEG 47MIN 22SEC E, 66.75 FEET; THENCE S 14DEG 04MIN 48SEC E, 424.02 FEET; THENCE S 88DEG 45MIN 27SEC W, 404.98 FEET TO THE EASTERLY RIGHT OF WAY OF SAID S.T.H. 67; THENCE ALONG SAID RIGHT OF WAY, N 01DEG 14MIN 32SEC W, 329.84 FEET TO THE POINT OF BEGINNING.
