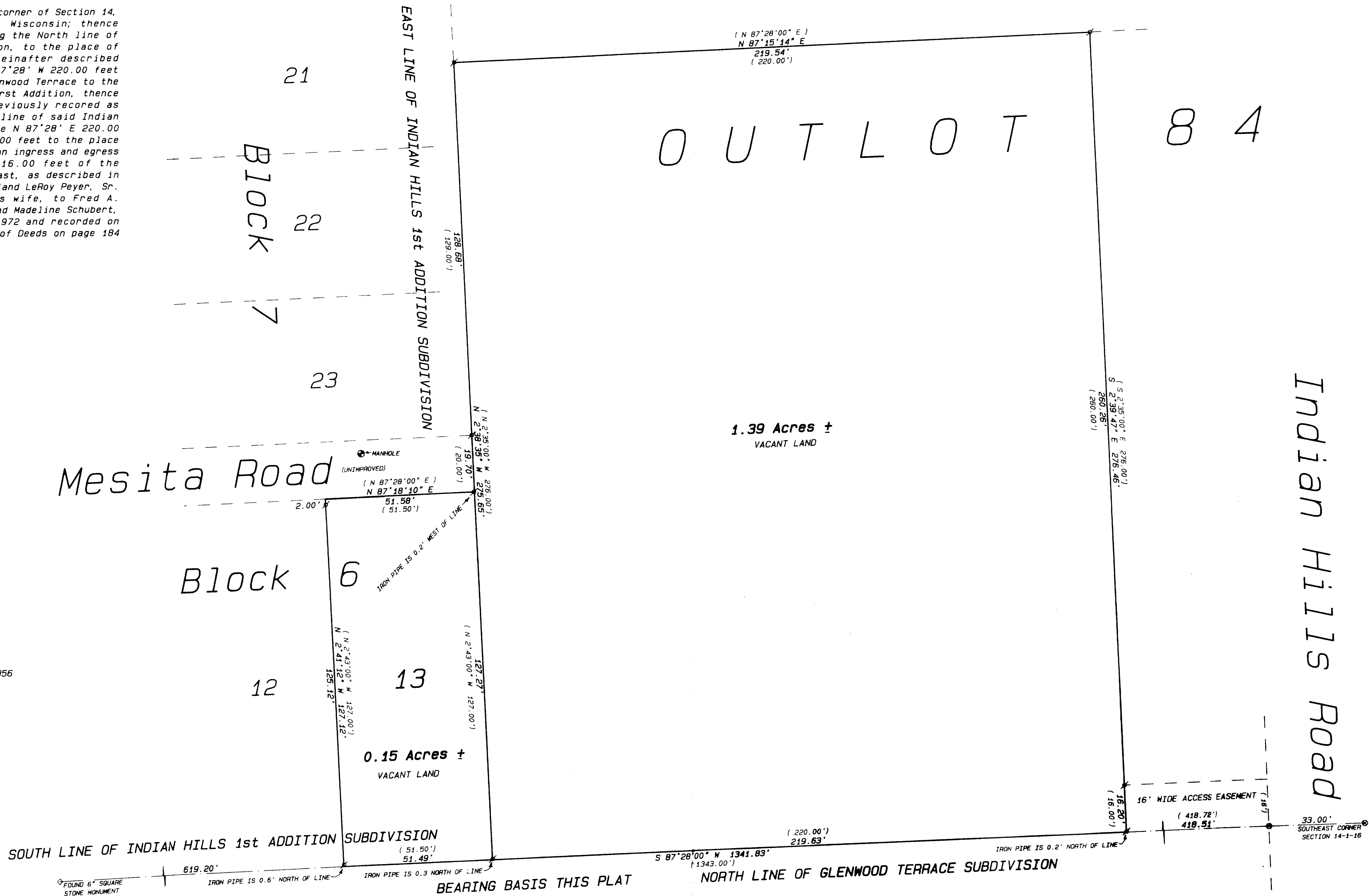

PLAT OF SURVEY

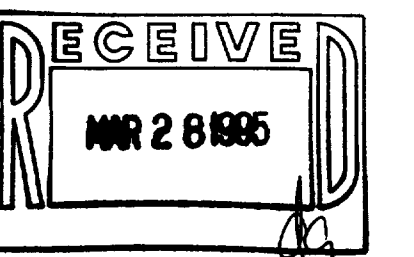
Legal Descriptions

Commencing at the Southeast corner of Section 14, T1N, R16E, Walworth County, Wisconsin; thence S 87°23' W 451.72 feet along the North line of Glenwood Terrace Subdivision, to the place of beginning at the lands hereinafter described to-wit: Thence continue S 87°28' W 220.00 feet along said North line of Glenwood Terrace to the SE corner of Indian Hills First Addition, thence N 02°35' W 276.00 feet (previously recorded as N 02°43' W) along the East line of said Indian Hills First Addition, thence N 87°28' E 220.00 feet, thence S 02°35' E 276.00 feet to the place of beginning, together with an ingress and egress easement over the South 16.00 feet of the adjoining premises on the East, as described in warranty deed executed by Leland LeRoy Peyer, Sr. and Patricia Ann Peyer, his wife, to Fred A. 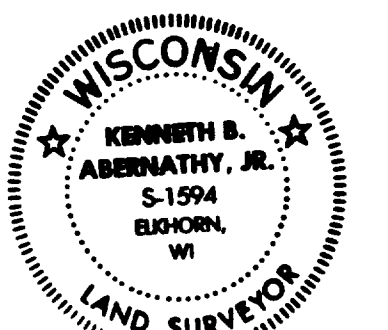
