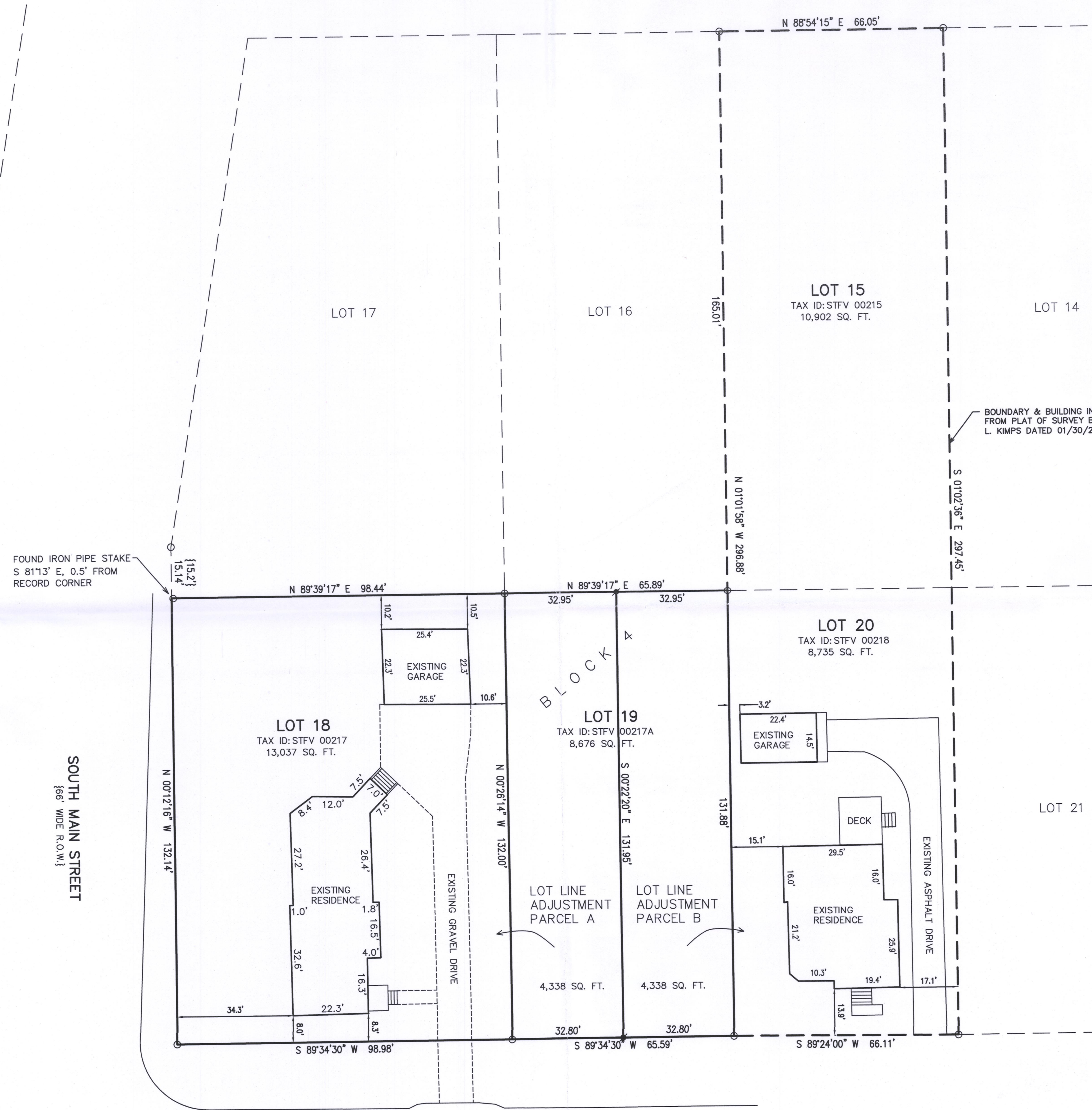


PLAT OF SURVEY FOR LOT LINE ADJUSTMENT

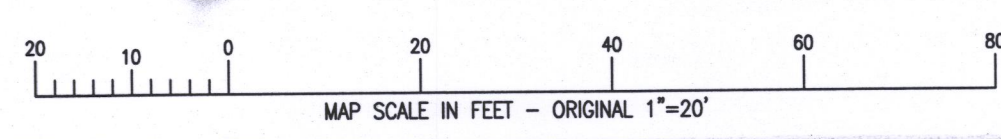
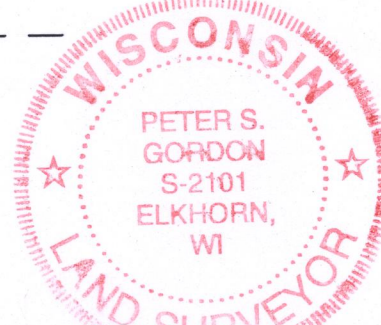

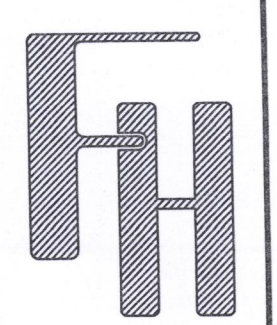
