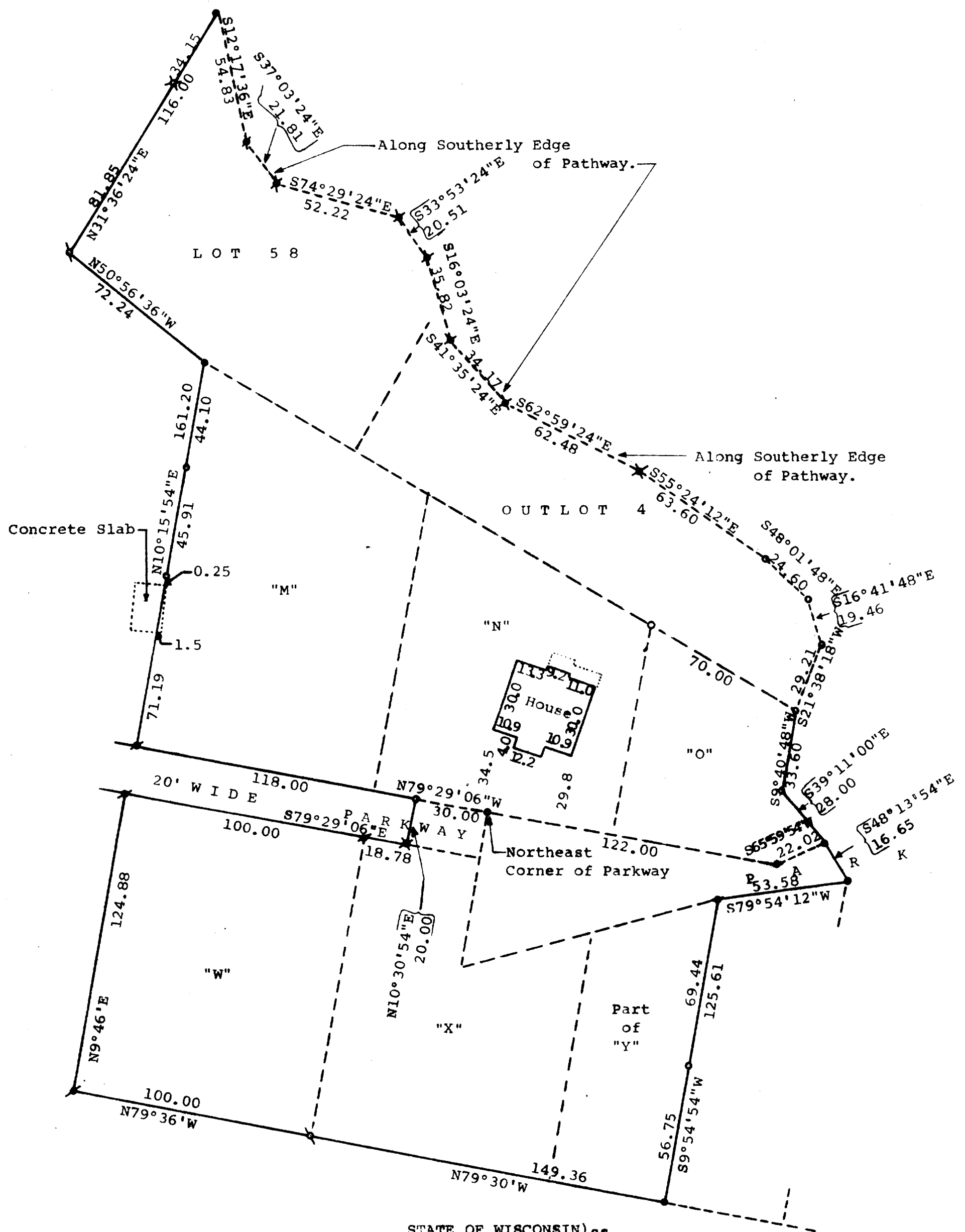

ALSO that part of Lot Y of said subdivision described as follows: Beginning at the Southwest corner of said Lot Y; thence Easterly, along the Southerly line of said Lot, 50 feet; thence Northerly on a line that is parallel with the East line of said Lot, 125.61 feet (described as 125 feet) to the northerly line of said Lot; thence Southwesterly, along the northerly line of said Lot Y, to the Northwest corner of said Lot; thence Southerly to the place of beginning,

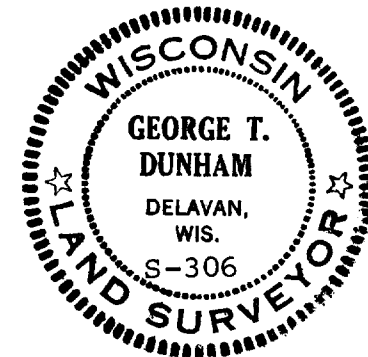
ALSO the East end of the Parkway in said Subdivision, described as follows: Beginning at the northeast corner of Parkway; thence Westerly along the south line of Lot N, 30 feet; thence Southerly at right angles to said line, 20.00 feet to the North line of said Lot X; thence Easterly, along said Lot line, 30.00 feet; thence Northerly, 20.00 feet to the place of beginning,

ALSO that part of the Park which lies West of a line from the Southeast corner of Lot O to the Northeast corner of Lot Y EXCEPT a 5 foot path lying in the south edge thereof.
