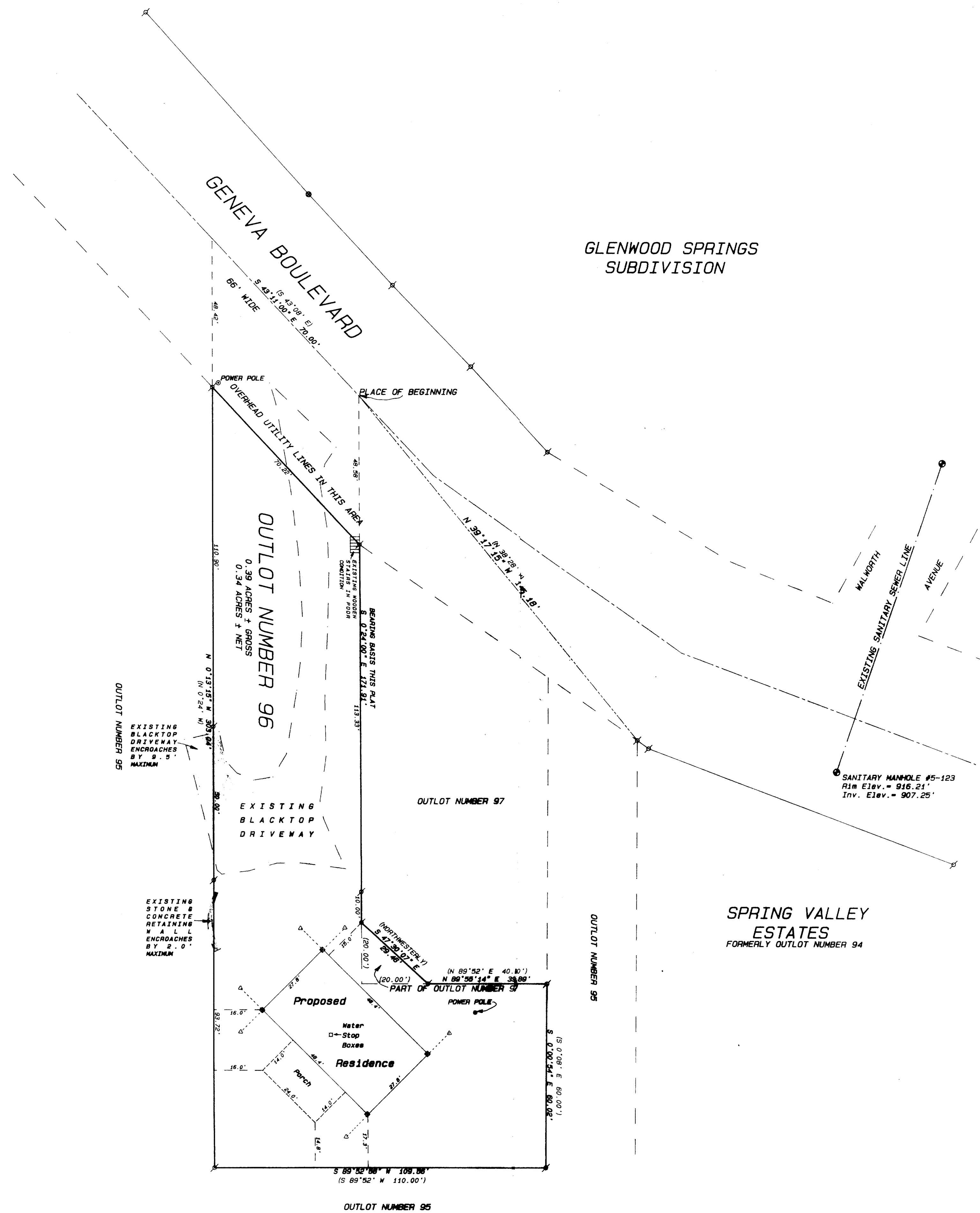
A parcel of land located in the Southeast 1/4 of Section 14, Village of Fontana, Walworth County, Wisconsin and described as follows; to-wit:

Commencing at the Northwest corner of Outlot 94 in said Southeast 1/4 of Section 14, thence N 38°28' W 145.18 feet to a spike in the centerline of Geneva Blvd. and the place of beginning; thence S 0°24' E 171.91 feet; thence S 47°33' E 29.50 feet; thence N 89°52' E 40.00 feet; thence S 0°08' E 60.00 feet; thence S 89°52' W 110.00 feet; thence N 0°24' W 303.04 feet to a spike in the centerline of Geneva Blvd.; thence S 43°08' E along said centerline 70.00 feet to the place of beginning.

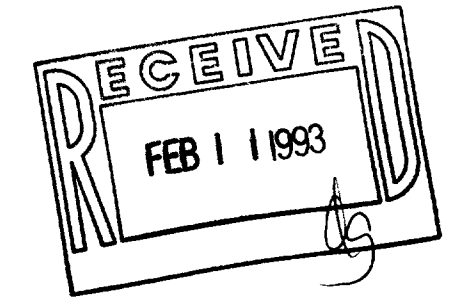

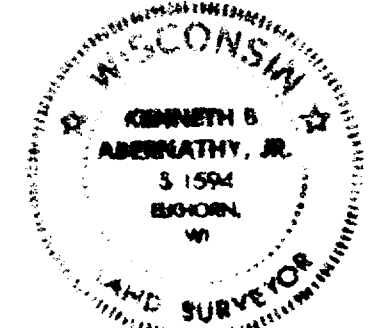
