


Commencing at a Found Concrete Monument at the Northeast Corner of said Section 23, thence S 87°28'00" W along the North Line of said Section 33.00 feet to a Found Concrete Monument on the West Right-of-way Line of Indian Hills Road; thence continue S 87°28'00" E along said Section Line 1226.58 feet (recorded as 1227.74 feet) to an Iron Pipe at a point 61.69 feet (recorded as 61.78 feet) Westerly of the Northeast Corner of Lot 52 and the point of beginning: thence continue S 87°28'00" W along said Section Line 82.25 feet (recorded as 82.29 feet) to a Found Stone Monument at the Northwest Corner of said subdivision; thence S 2'38'10" E 232.19 feet (recorded as 232.30 feet) to an Iron Pipe on the Southerly Right-of-way Line of the discontinued portion Berwyn Drive; thence N 87°28'27" E along said Southerly Right-of-way Line 71.99 feet (recorded as 72.00 feet) to an Iron Pipe; thence N 2°37'45" W along the relocated Westerly Right-of-way Line of Elm Street 40.00 feet to an Iron Pipe on the Northerly Right-of-way Line of Berwyn Drive; thence N 87°28'27" E along said right-of-way line 10.22 feet (recorded as 10.26 feet) to an Iron Pipe; thence N 2°37'34" W 192.20 feet (recorded as 192.30 feet) to the point of beginning. Said parcel contains 0.429 Acres of land more or less and is subject to easesments recorded or unrecorded.


