
# PLAT OF SURVEY

### **DESCRIPTION:**

#### PARCEL NO. 1

A PARCEL OF LAND LOCATED IN THE NORTHEAST FRACTIONAL 1/4 OF SECTION 13, TOWNSHIP 1 NORTH, RANGE 16 EAST, BEING ALSO PART OF OUTLOT 52 OF THE ASSESSOR'S PLAT NO. 1 AMENDED TO THE VILLAGE OF FONTANA, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS; COMMENCING AT THE SOUTHEAST CORNER OF THE NORTHEAST 1/4 OF SAID SECTION 13 ; THENCE N 88'45' W ALONG THE 1/4 SECTION LINE 110.10 FEET TO THE POINT OF BEGINNING; THENCE CONTINUE N 88'45' W 100.88 FEET; THENCE N 00'47'40" E 400.00 FEET; THENCE S 88'45' E 100.88 FEET; THENCE S 00'47'40" W 400.00 FEET TO THE POINT OF BEGINNING.

A PARCEL OF LAND LOCATED IN THE NORTHEAST FRACTIONAL 1/4 OF SECTION 13, TOWNSHIP 1 NORTH, RANGE 16 EAST, BEING ALSO PART OF OUTLOT 52 OF THE ASSESSOR'S PLAT NO. 1 AMENDED TO THE VILLAGE OF FONTANA, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS; COMMENCING AT THE SOUTHEAST CORNER OF THE NORTHEAST 1/4 OF SAID SECTION 13; THENCE N 88'45' W ALONG THE 1/4 SECTION LINE 110.10 FEET; THENCE N 00'47'40" E 400.00 FEET TO THE POINT OF BEGINNING ; THENCE N 88°45' W 100.88 FEET ; THENCE N 00°47'40" E 607.59 FEET MORE OR LESS TO THE SHORE OF GENEVA LAKE; THENCE NORTHEASTERLY ALONG THE THE SHORE TO A POINT THAT IS LOCATED 100.88 FEET EASTERLY OF THE PREVIOUS COURSE; THENCE S 00'47'40" W 633.29 FEET MORE OR LESS TO THE POINT OF BEGINNING.


