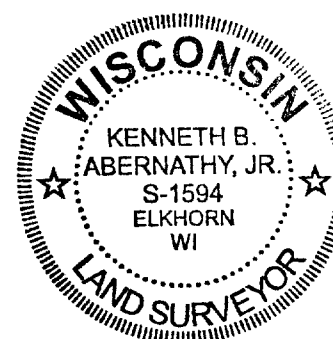
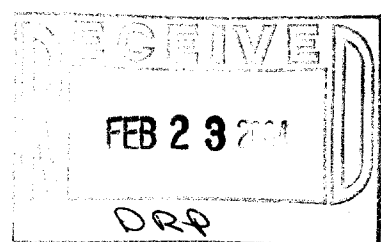
Area of Questionable Ownership

Found P.K. nails and a pipe on Lot 15 would indicate the 6' wide walkway is West of its true location based on the record dimension of 37.9 feet along the arc for Lot 16. In light of this discrepancy we have labeled this triangle as "Area of Questionable Ownership."
