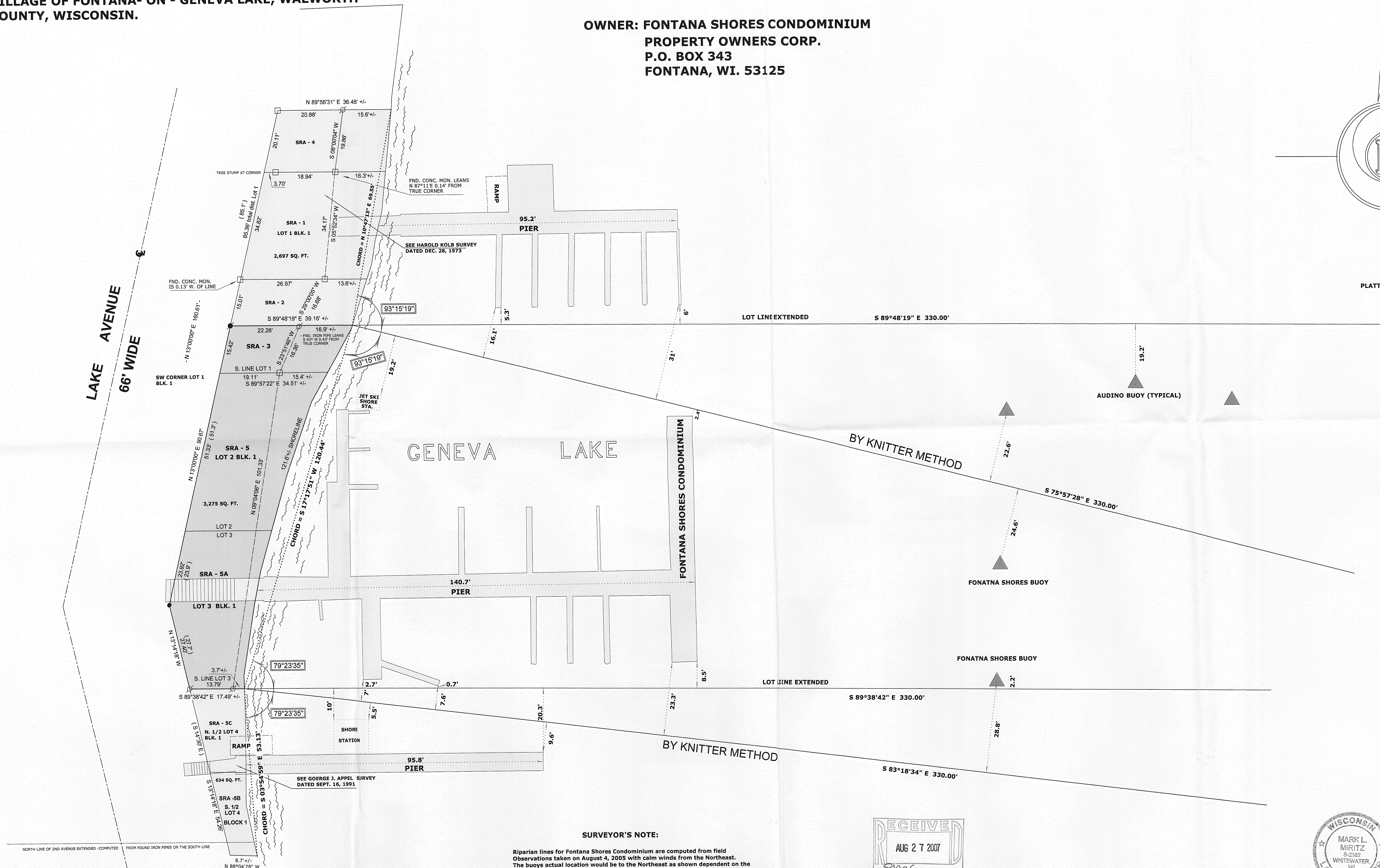
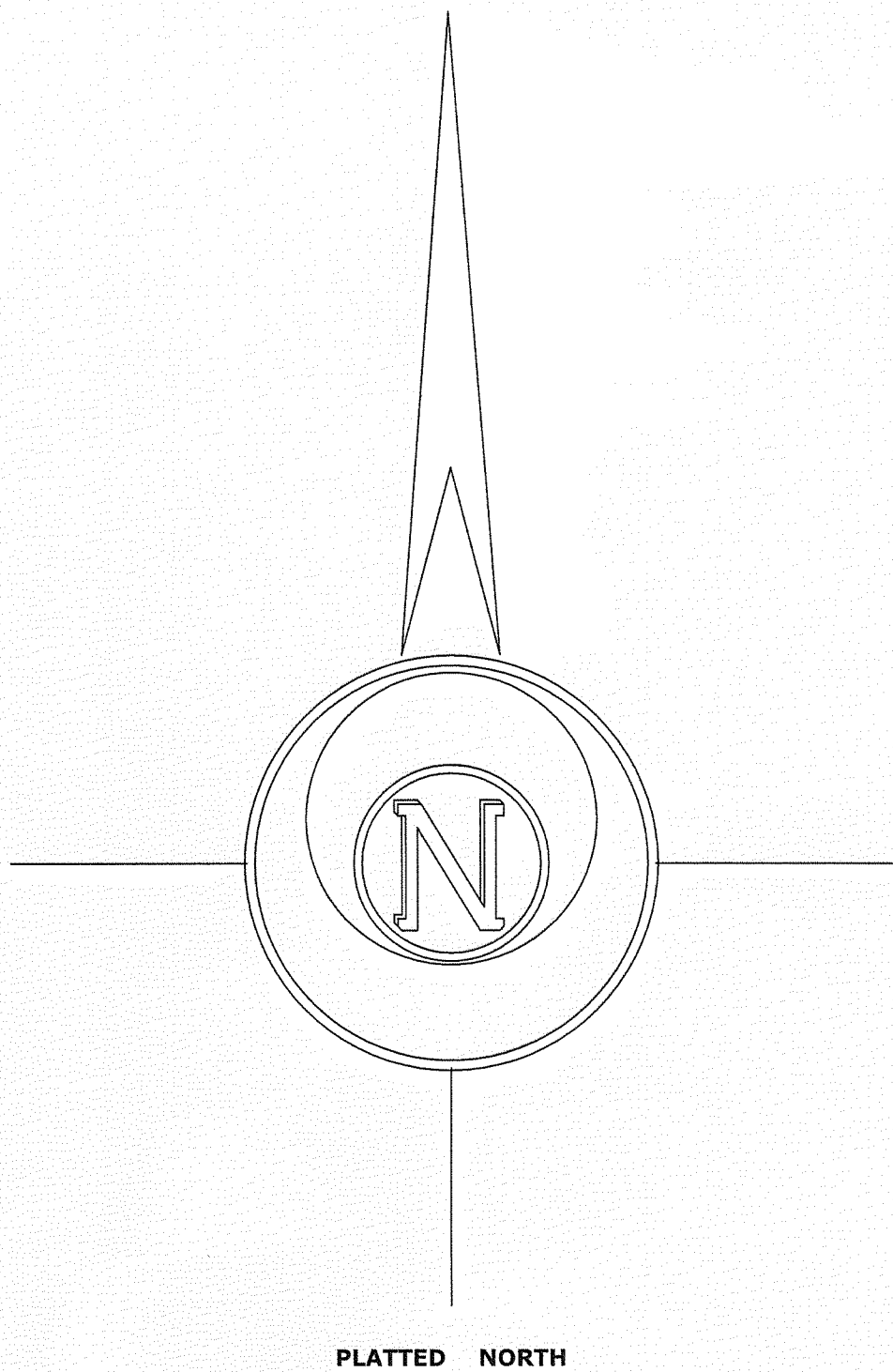

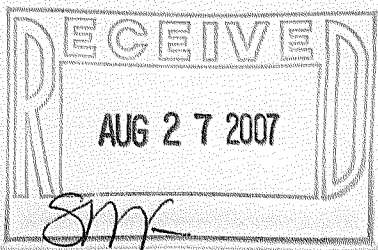
PLAT OF SURVEY

SURVEYOR'S NOTE:

Riparian lines for Fontana Shores Condominium are computed from field observations taken on August 4, 2005 with calm winds from the Northeast. The buoys actual location would be to the Northeast as shown dependent on the length of line between the anchor and the buoy. The riparian lines were computed using the "KNITTER METHOD" (also called the coterminal method), which uses the angle of the chords formed by the lot lines extended to the shoreline. The shoreline was established by locating the elevation of 864.3 feet (mean sea level datum) as per Village of Fontana Ordinance Section 54-82. The angle is then bisected to compute the riparian line. The riparian lines using the "LOT LINE EXTENDED" is also shown. The piers were located at the outside of the crib posts.
