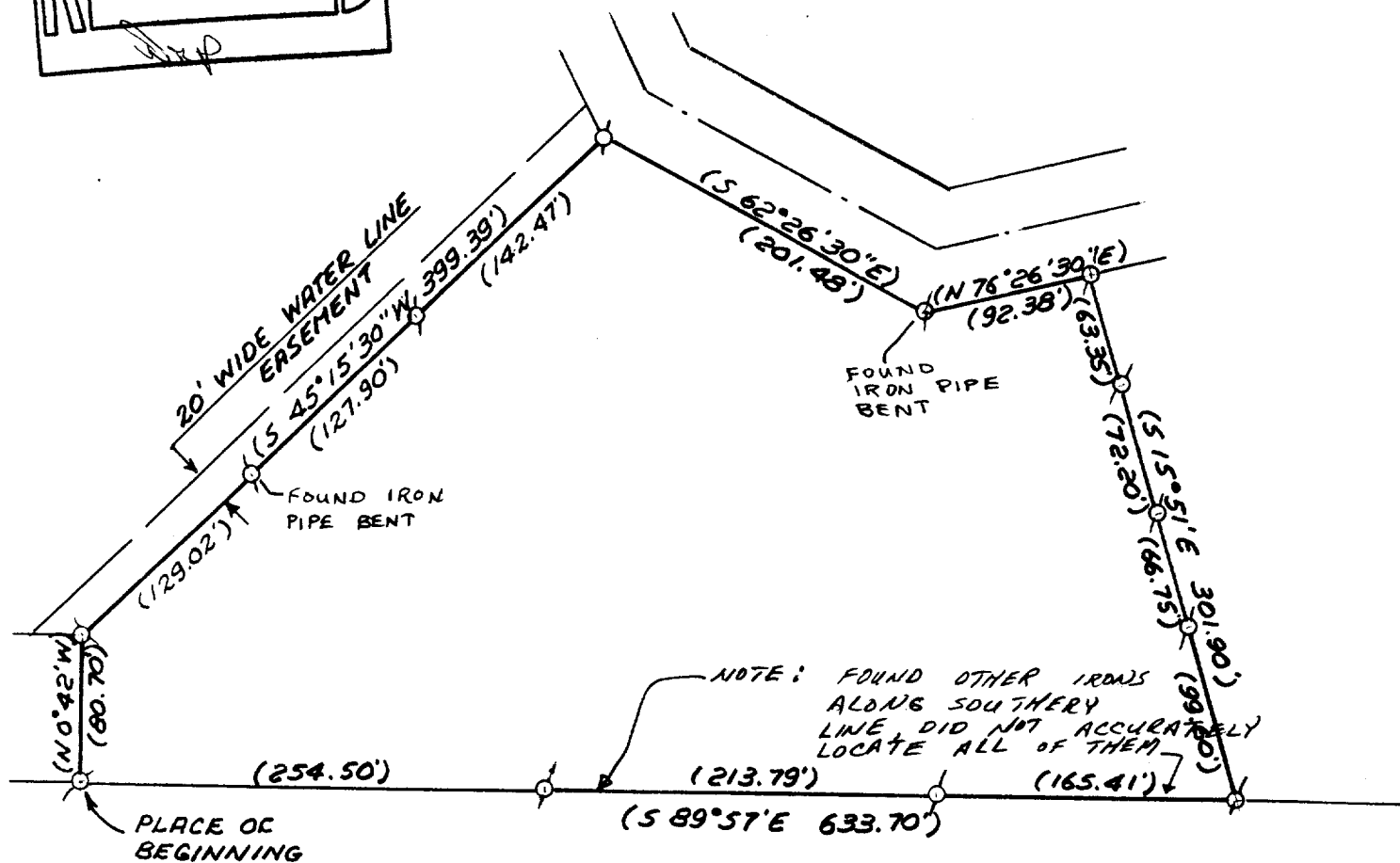

ALL THAT PART OF THE SOUTHWEST 1/4 OF SECTION 18, TOWN 1 NORTH, RANGE 17 EAST, WALWORTH COUNTY, WISCONSIN, BOUNDED AND DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHWEST CORNER OF BROOKWOOD SUBDIVISION, WHICH POINT IS SOUTH 0°42' EAST 744.22 FEET OF THE WEST 1/4 SECTION CORNER OF SAID SECTION 18 AND RUN THENCE SOUTH 0°42' EAST 858.40 FEET TO THE SOUTH LINE OF THE NORTH 4.32 CHAINS OF THE SOUTHWEST 1/4 OF THE SOUTHWEST 1/4 OF SAID SECTION 18; THENCE SOUTH 89°57' EAST ALONG SAID SOUTH LINE 80.00 FEET TO THE PLACE OF BEGINNING OF THE PARCEL OF LAND HEREINAFTER DESCRIBED; THENCE CONTINUE SOUTH 89°57' EAST 633.70 FEET; THENCE NORTH 15°51' WEST 301.90 FEET; THENCE SOUTH 76°26'30" WEST 92.38 FEET; THENCE NORTH 62°26'30" WEST 201.48 FEET; THENCE SOUTH 45°15'30" WEST 399.39 FEET; THENCE SOUTH 0°42' EAST 80.70 FEET TO THE PLACE OF BEGINNING.
