



PLAT OF SURVEY

LEGAL DESCRIPTION:

A parcel of land located in the Northeast Quarter of Section 35, Town 1 North, Range 18 East, Village of Genoa City, Walworth County, Wisconsin, described as follows: Commencing at a point 8 rods North of the Southeast corner of North Half of the Northeast Quarter of the Northeast Quarter of Section 35, Township 1 North, Range 18 East, running thence West 8 rods, running thence North 8 rods, thence East 8 rods, thence South 8 rods to the Place of Beginning. Also, part of the said Northeast Quarter, being described as follows: Commencing at a point 8 rods West and 8 rods North of the Southeast corner of the North Half of the Northeast Quarter of the Northeast Quarter of Section 35, Township 1 North, Range 18 East, run thence North 8 rods, thence West 10 rods, thence South 8 rods, thence East 10 rods to the Place of Beginning. Also, part of the Northeast Quarter of said Section 35, being described as follows: Beginning at a point 40 rods South and 18 rods West of the Northeast corner of said Section 35; thence West 165 feet, thence North 264 feet, thence East 164 feet, thence south 264 feet to the Place of Beginning, said land being in the Village of Genoa City, County of Walworth, and State of Wisconsin.
