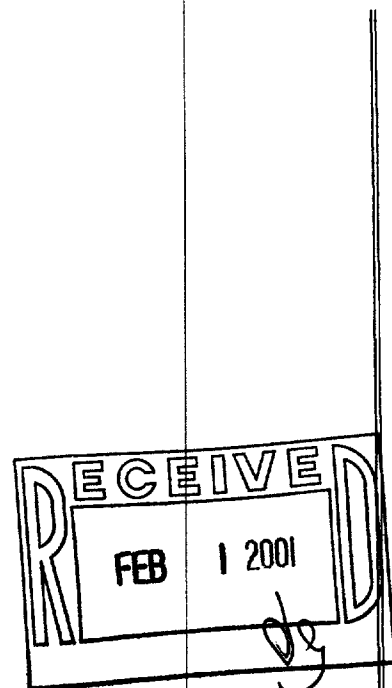

## PLAT OF SURVEY

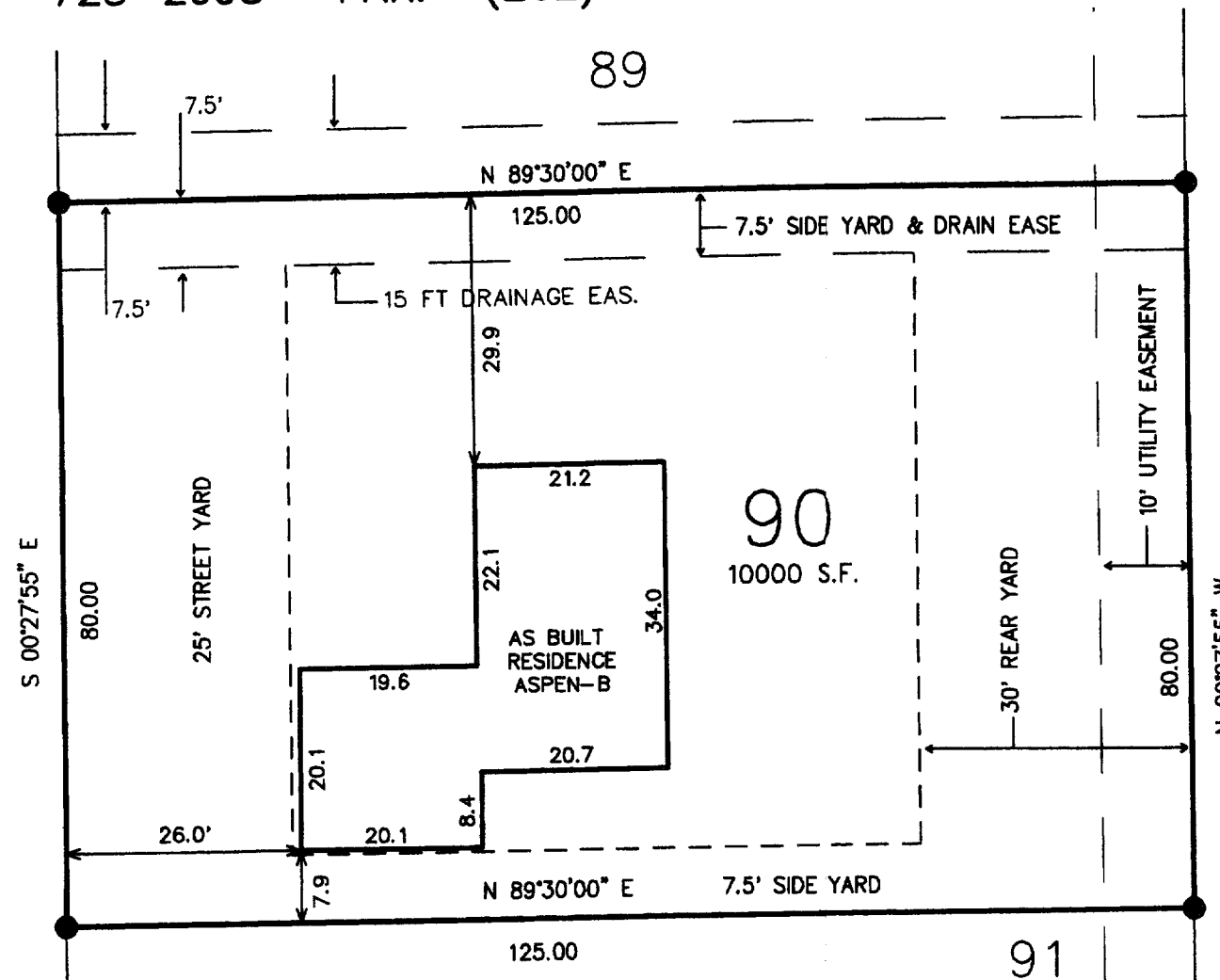
### LOT 90 OF HUNTERS RIDGE SUBDIVISION

VILLAGE OF GENOA CITY, WALWORTH COUNTY, WISCONSIN

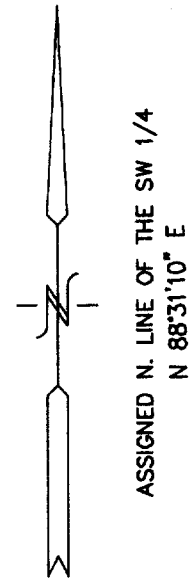


TEAL TRAIL

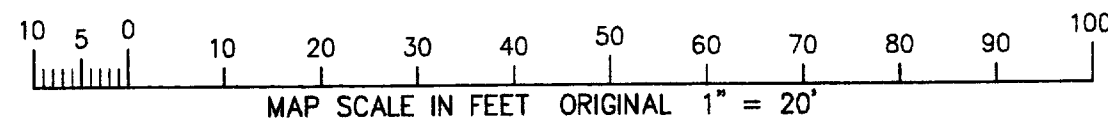
