A parcel of land located in the East 1/2 of Section 35, T2N, R17E, City of Lake Geneva, Walworth County, Wisconsin, described as follows, to-wit: Commencing at the NE corner of Lake Geneva Manor Subdivision of said City of Lake Geneva on the Southerly line of Main Street; thence N 67° 25' East along the Southerly line of said Main Street 85.00 feet more or less to the place of beginning; thence S 21° 29' East 180.31 feet more or less to an iron pipe; thence N 68° 15' East 59.54 feet more or less to an iron pipe; thence S 50° 48' East 137.05 feet more or less to an iron pipe; thence S 30° 15' East 326.20 feet more or less to the shore of Geneva Lake; thence Northeasterly along the shore of Geneva Lake 80.00 feet to the SW corner of land now owned by Karl M. Keck; thence N 33° 42' West along the Westerly line of said Karl M. Keck property 347.10 feet more or less to an iron pipe; thence N 17° 42' West along the Westerly line of said Karl M. 
