

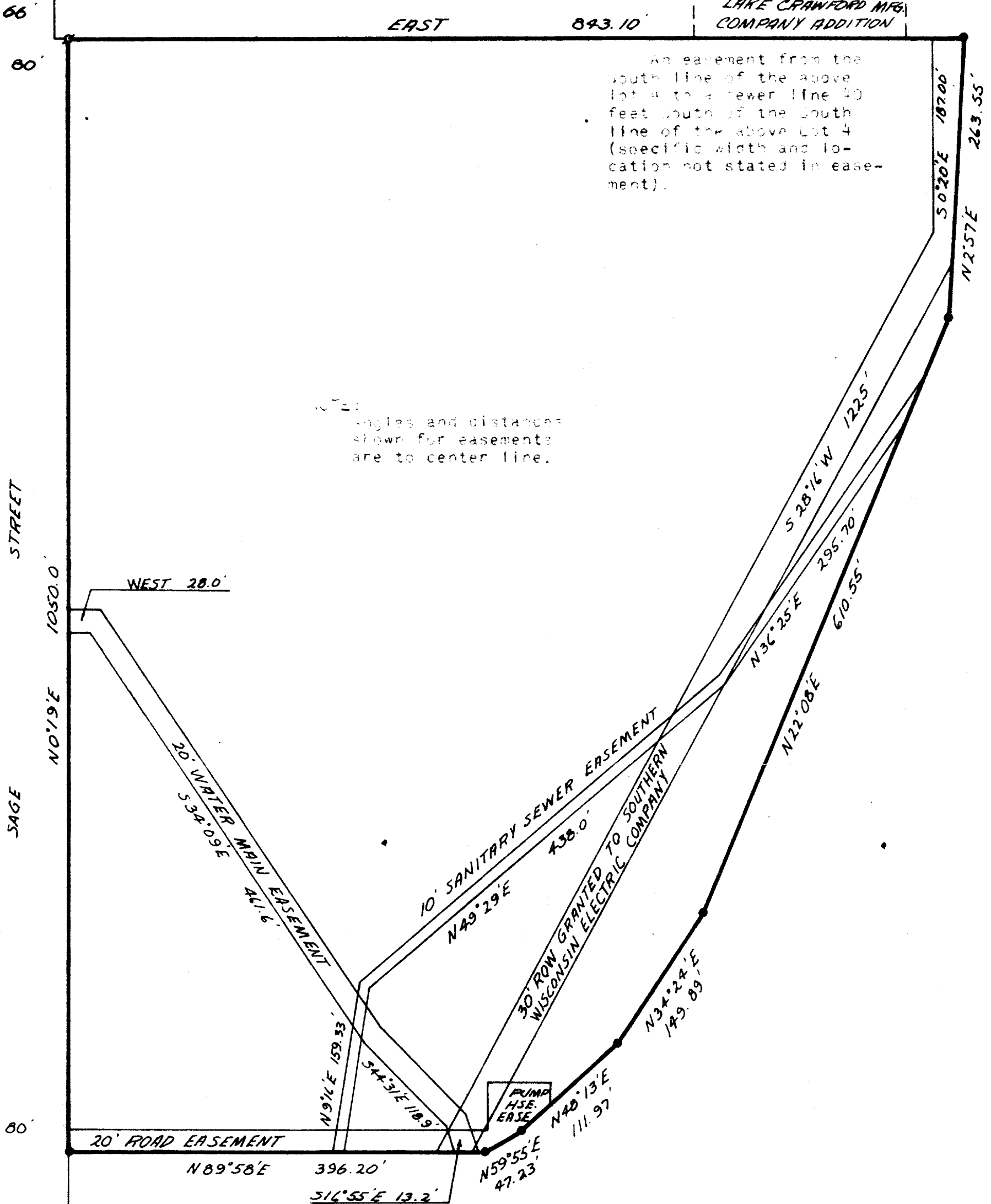

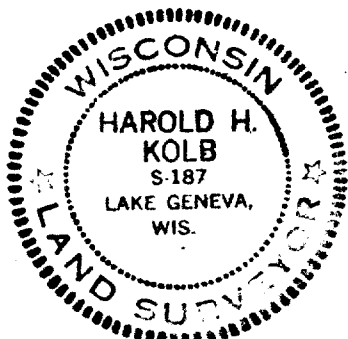
PLAT OF

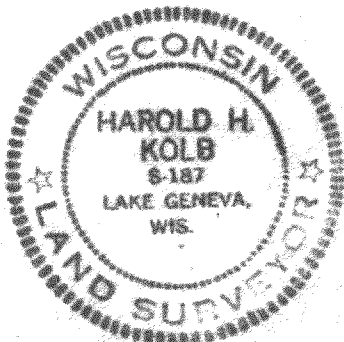
