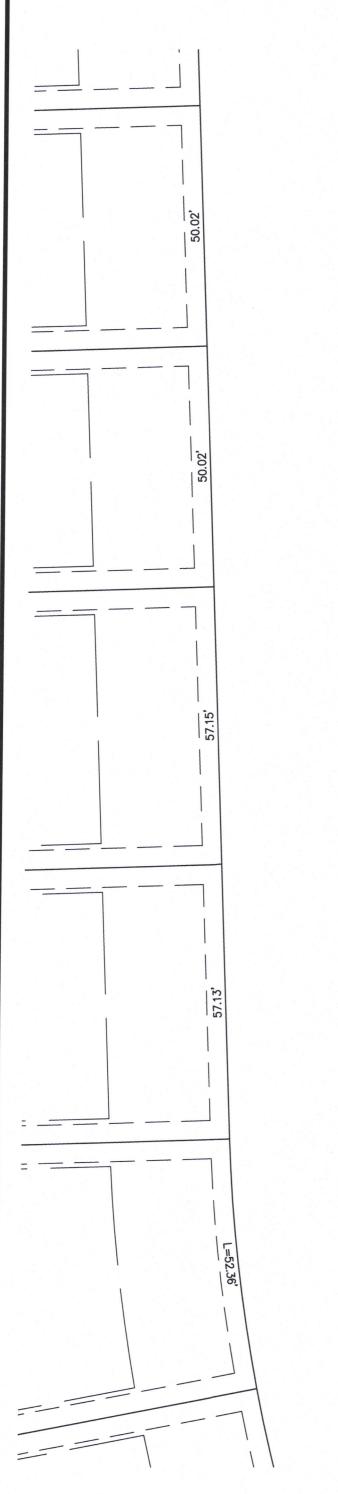


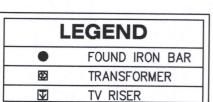
## PLAT OF SURVEY

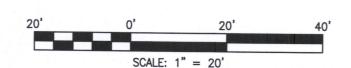
