

PLAT OF SURVEY

LEGAL DESCRIPTION:
A PARCEL OF LAND LOCATED IN THE NORTHEAST 1/4 OF THE SOUTHWEST 1/4, THE NORTHWEST AND SOUTHWEST 1/4 OF THE SOUTHEAST 1/4, AND THE SW 1/4 OF THE NORTHEAST 1/4 OF SECTION 35 IN TOWNSHIP 2 NORTH, RANGE 17 EAST, IN THE CITY OF LAKE GENEVA, WALWORTH COUNTY, WISCONSIN.

PARCEL B, COMMENCING AT THE SOUTHERN 1/4 CORNER OF SECTION 35, TOWNSHIP 2 NORTH, RANGE 17 EAST, THENCE N01°05'34"W ALONG THE EASTERN QUARTER LINE OF THE SW QUARTER OF SAID SECTION 35, 813.89' TO THE POINT OF BEGINNING, THENCE N01°05'34"W ALONG THE EASTERN QUARTER LINE OF THE SOUTHWEST QUARTER OF SAID SECTION 35, 1213.79', THENCE S83°36'30"W 12.07', THENCE S61°04'59"W 101.01', THENCE ALONG A CURVE TO THE LEFT WITH A CHORD BEARING AND DISTANCE OF S45°09'45"W 138.31', A RADIUS OF 264.00', AND AN ARC LENGTH OF 138.31', THENCE S30°46'34"W 152.28', THENCE ALONG A CURVE TO THE RIGHT WITH A CHORD BEARING AND DISTANCE OF S41°17'17"E 231.59', A RADIUS OF 732.00', AND AN ARC LENGTH OF 232.56', THENCE ALONG A CURVE TO THE LEFT WITH A CHORD BEARING AND DISTANCE OF S27°24'08"W 185.54', A RADIUS OF 247.00', AND AN ARC LENGTH OF 190.20', THENCE ALONG A CURVE TO THE LEFT WITH A CHORD BEARING AND DISTANCE OF S16°12'39"E 214.01', A RADIUS OF 509.59', AND AN ARC LENGTH OF 215.62', THENCE S16°12'39"E 81.85', THENCE ALONG A CURVE TO THE RIGHT WITH CHORD BEARING AND DISTANCE S16°12'39"E 61.37', A RADIUS OF 521.00', AND AN ARC LENGTH OF 61.41', THENCE ALONG A CURVE TO THE RIGHT WITH CHORD BEARING AND DISTANCE S6°22'48"E 231.95', A RADIUS OF 2673.00', AND AN ARC LENGTH OF 252.09', THENCE N89°59'27"E 400.12' TO THE PLACE OF BEGINNING. ALSO INCLUDES ALL LANDS BETWEEN THE SOUTHERN RIGHT OF WAY LINE AND THE CENTERLINE OF SNAKE ROAD.
