

THAT PORTION OF OUTLOT NO. 1 OF THE LAKE GENEVA MANOR, TRACT 17, LAKE GENEVA, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS, TO-WIT: COMMENCING AT A POINT IN THE NE'LY LINE OF SAID OUTLOT 149.5 FEET SE'LY FROM THE NORTH CORNER OF SAID OUTLOT; THENCE \$24°10'W 159.6 FEET TO THE SE CORNER OF LOT 1, BLOCK 14, OF SAID SUBDIVISION; THENCE N75°04'W 74.75 FEET ALONG THE NE'LY LINE OF SAID LOT 1; THENCE N24°37'E 150.6 FEET TO A POINT IN THE NE'LY LINE OF SAID OUTLOT NO. 1; THENCE \$68°07'E 74.75 FEET TO THE PLACE OF BEGINNING.
