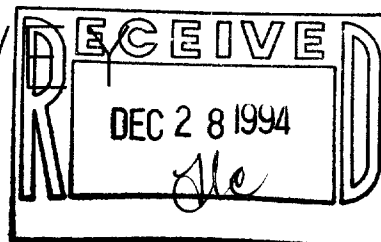
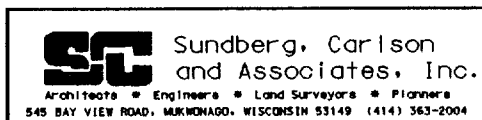


PLAT OF SURVEY

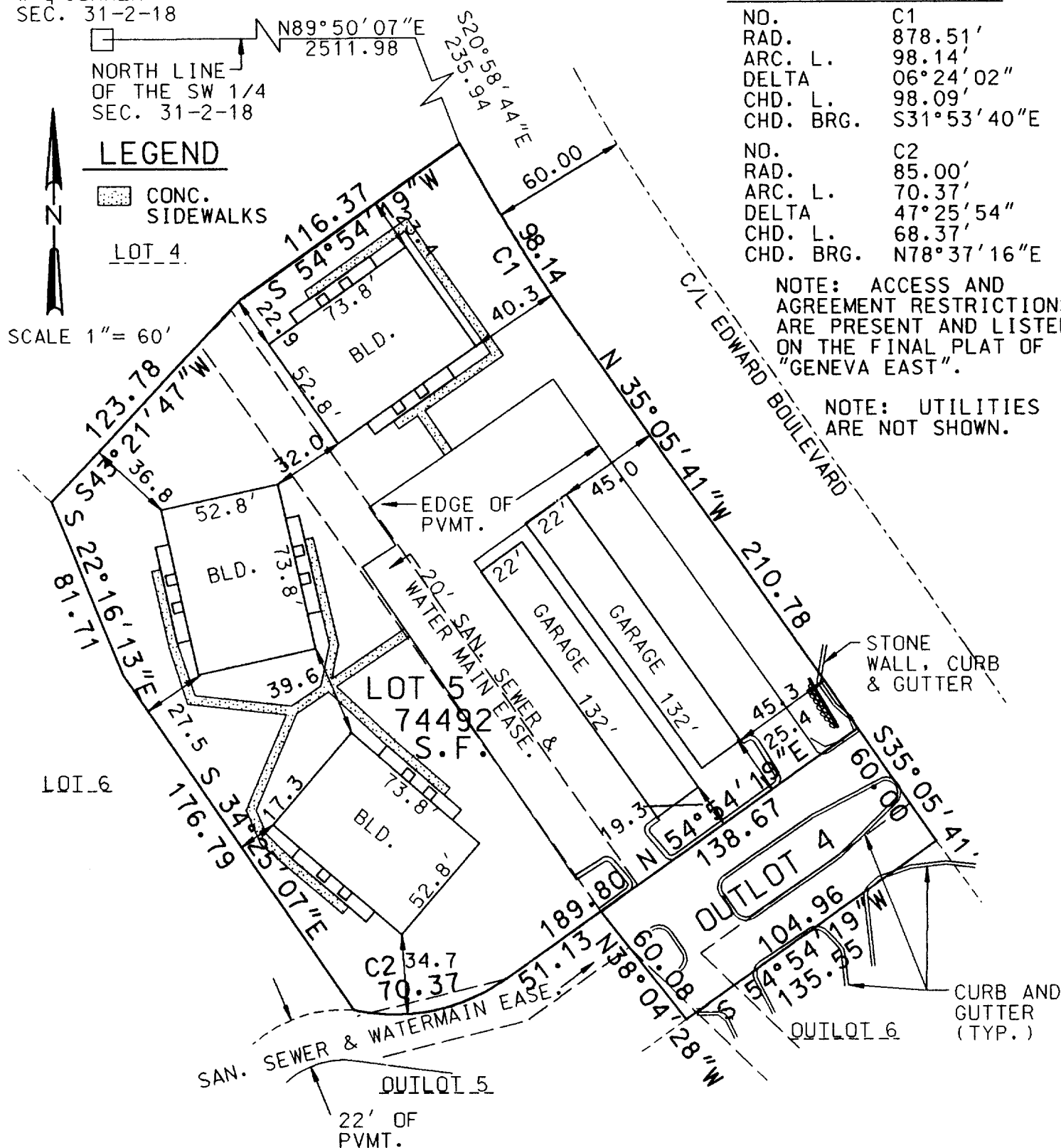
