

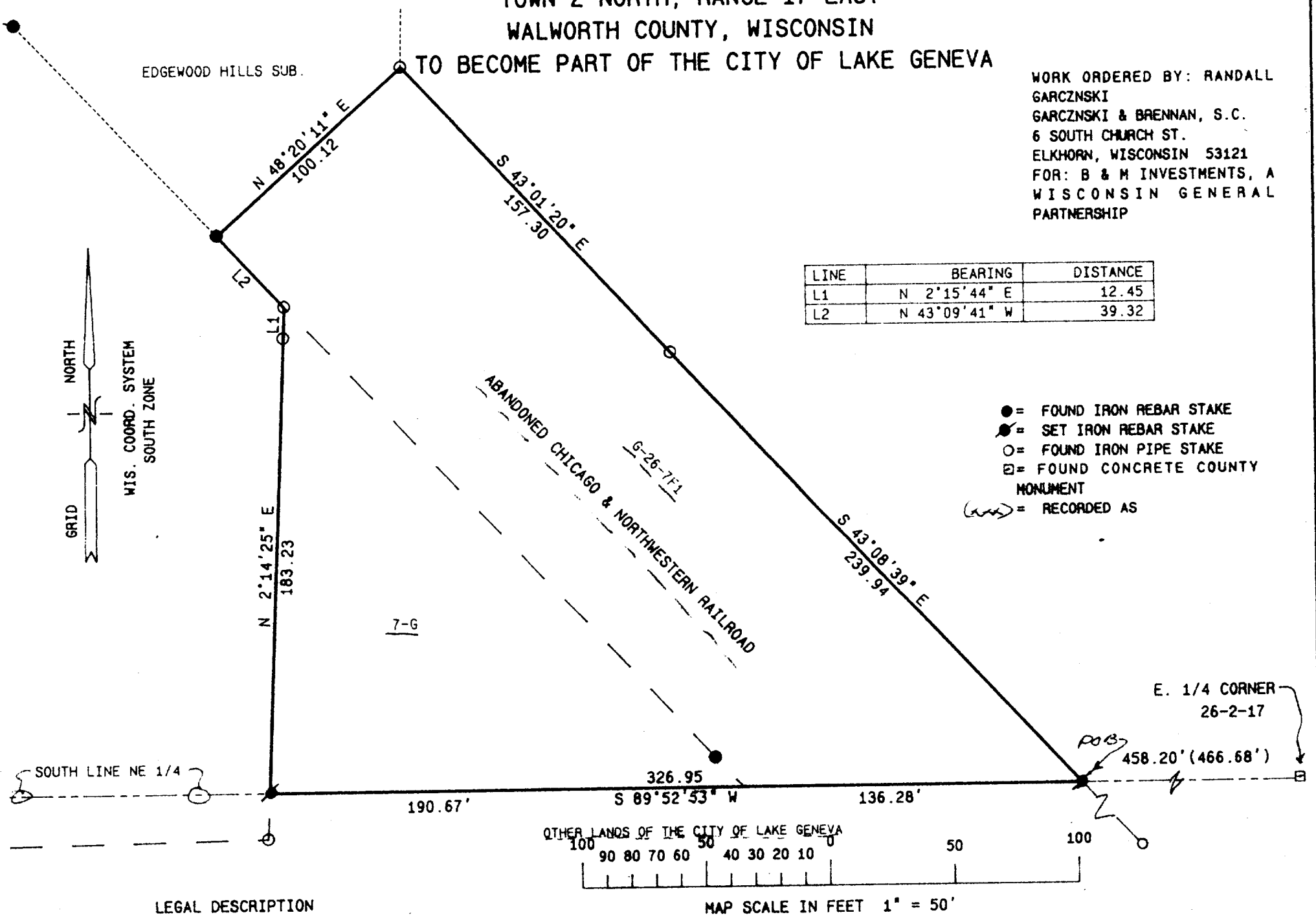

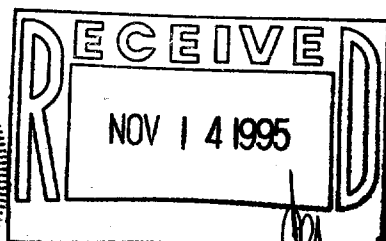
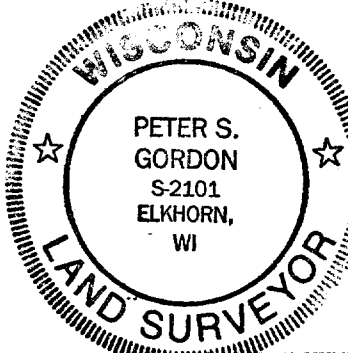
LEGAL DESCRIPTION
