LEGAL DESCRIPTION

REFERENCE LEGAL QCD VOL. 372 P. 3 DOC. NO. 130867

A parcel of land located in the Northeast 1/4 of Section 25, Township 2 North, Range 17 East, City of Lake Geneva, Wisconsin, described as follows, to-wit: Commencing at the intersection of the center line of Sheridan Road and the East line of said Section as fenced, thence South 86°54' West 1269.56 feet along the centerline of Sheridan Road to the place of beginning, thence continue along the centerline of Sheridan Road South 86°54' West 114.15 feet to a point, thence North 17°50' West 358.60 feet to a point in the Easterly right-of-way line of State Trunk Highway No. 36 as of this day of August 29, 1957; thence North 54°10' East along said right-of-way line 116.08 feet; thence South 17°50' East 423.51 feet to the place of beginning, Walworth County, Wisconsin.

Also Commencing at a point that is 1164.22 feet S 86°54' W of the intersection of the East line of Section 25, T2N, Range 17 East, and the North line of Sheridan Road in the City of Lake Geneva, Walworth County, Wisconsin; thence N 17°50' W 457.51 feet to an iron stake; thence S 54°10' W 107.12 feet along the southerly right of way line of State Trunk Highway #36 to an iron stake; thence S 17°50' E 397.62 feet to an iron stake; thence N 86°54' E 105.34 feet to the place of beginning.

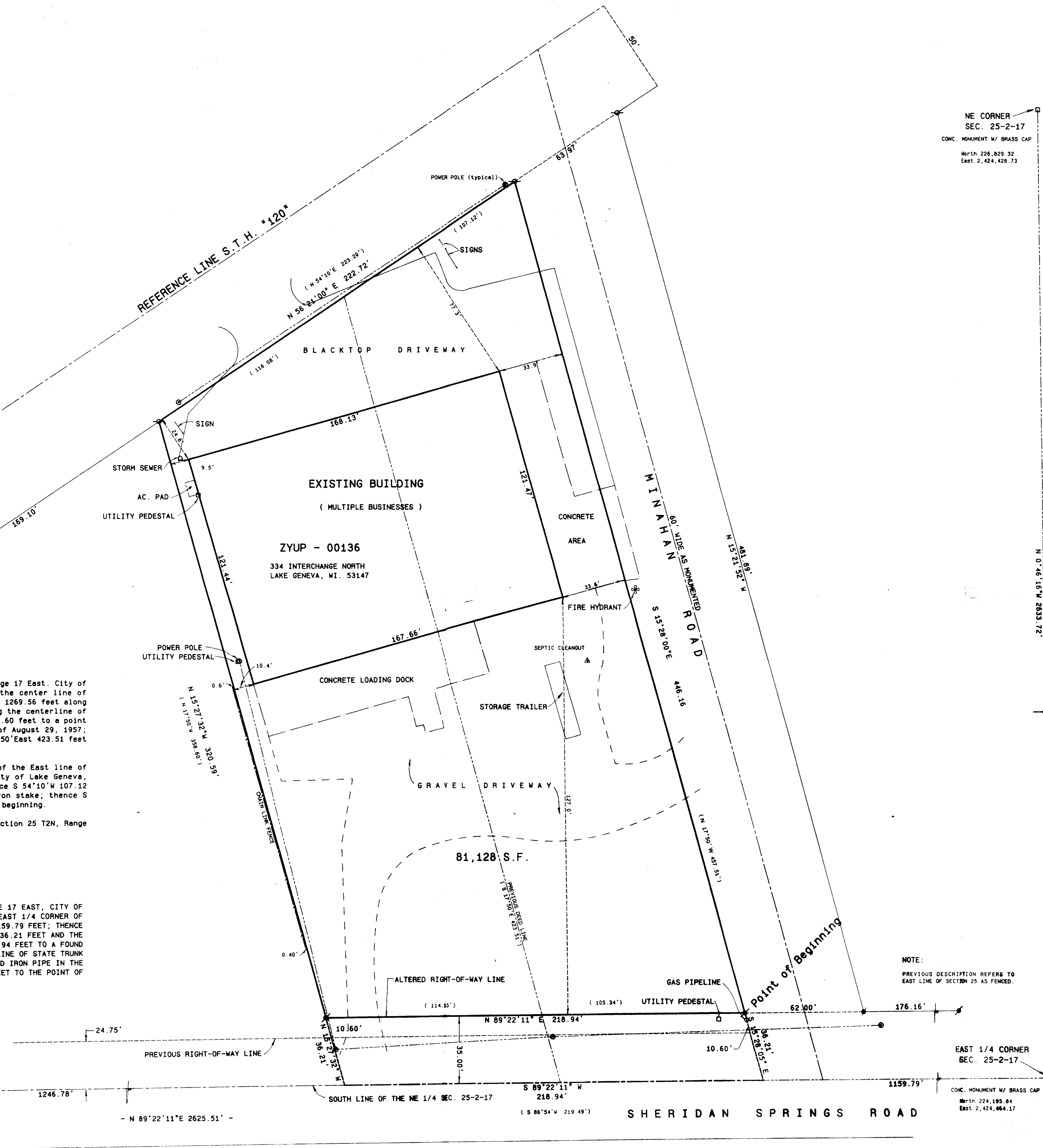

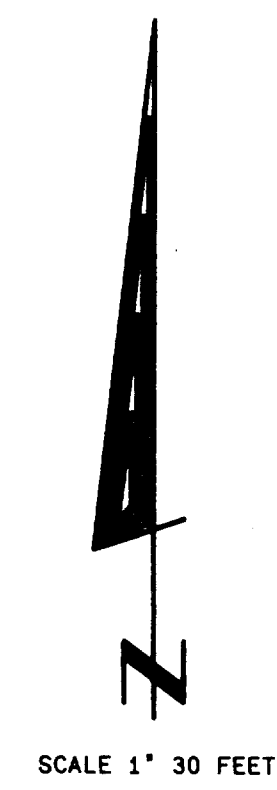
A PARCEL OF LAND LOCATED IN THE NORTHEAST 1/4 OF SECTION 25, TOWN 2 NORTH, RANGE 17 EAST, CITY OF LAKE GENEVA, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: COMMENCE AT THE EAST 1/4 CORNER OF SAID SECTION 25; THENCE S 89°22'11" W ALONG THE SOUTH LINE OF THE NORTHEAST 1/4, 1159.79 FEET; THENCE N 15°28'05" W TO A FOUND IRON ROD IN THE NORTHERLY LINE OF SHERIDAN SPRINGS ROAD 36.21 FEET AND THE POINT OF BEGINNING; THENCE S 89°22'11" W ALONG THE NORTHERLY LINE OF SAID ROAD 218.94 FEET TO A FOUND IRON ROD; THENCE N 15°27'32" W 320.59 FEET TO A FOUND IRON PIPE IN THE SOUTHERLY LINE OF STATE TRUNK HIGHWAY "120"; THENCE N 56°21'00" E ALONG SAID HIGHWAY LINE 222.72 FEET TO A FOUND IRON PIPE IN THE WESTERLY LINE OF MINAHAN ROAD; THENCE S 15°28'00" E ALONG SAID ROAD LINE 446.16 FEET TO THE POINT OF BEGINNING. SAID PARCEL CONTAINS 1.86 ACRES OF LAND MORE OR LESS.

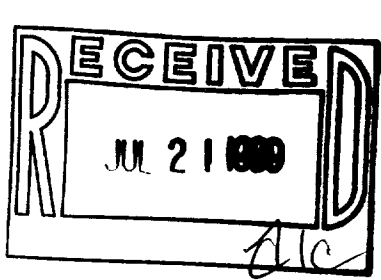


Horizontal Datum is based on the Wisconsin State Plane Coordinate System Grid, South Zone, and all bearings are referred to Grid North.
