PARCEL A: COMMENCING AT THE NORTHWEST CORNER OF LOT 6 IN BLOCK 13, IN THE CITY OF LAKE GENEVA, COUNTY OF WALWORTH, STATE OF WISCONSIN, THENCE SOUTH IN THE WEST LINE OF SAID LOT 6, 24 FEET; THENCE EAST PARALLEL WITH THE NORTH LINE OF SAID LOT AND LOT 5 TO THE EAST LINE OF SAID LOT 5; THENCE NORTH IN THE EAST LINE OF LOT 5 TO THE NORTH LINE OF SAID LOT 5; THENCE WEST IN THE NORTH LINE OF LOTS 5 AND 6 TO THE PLACE OF BEGINNING.

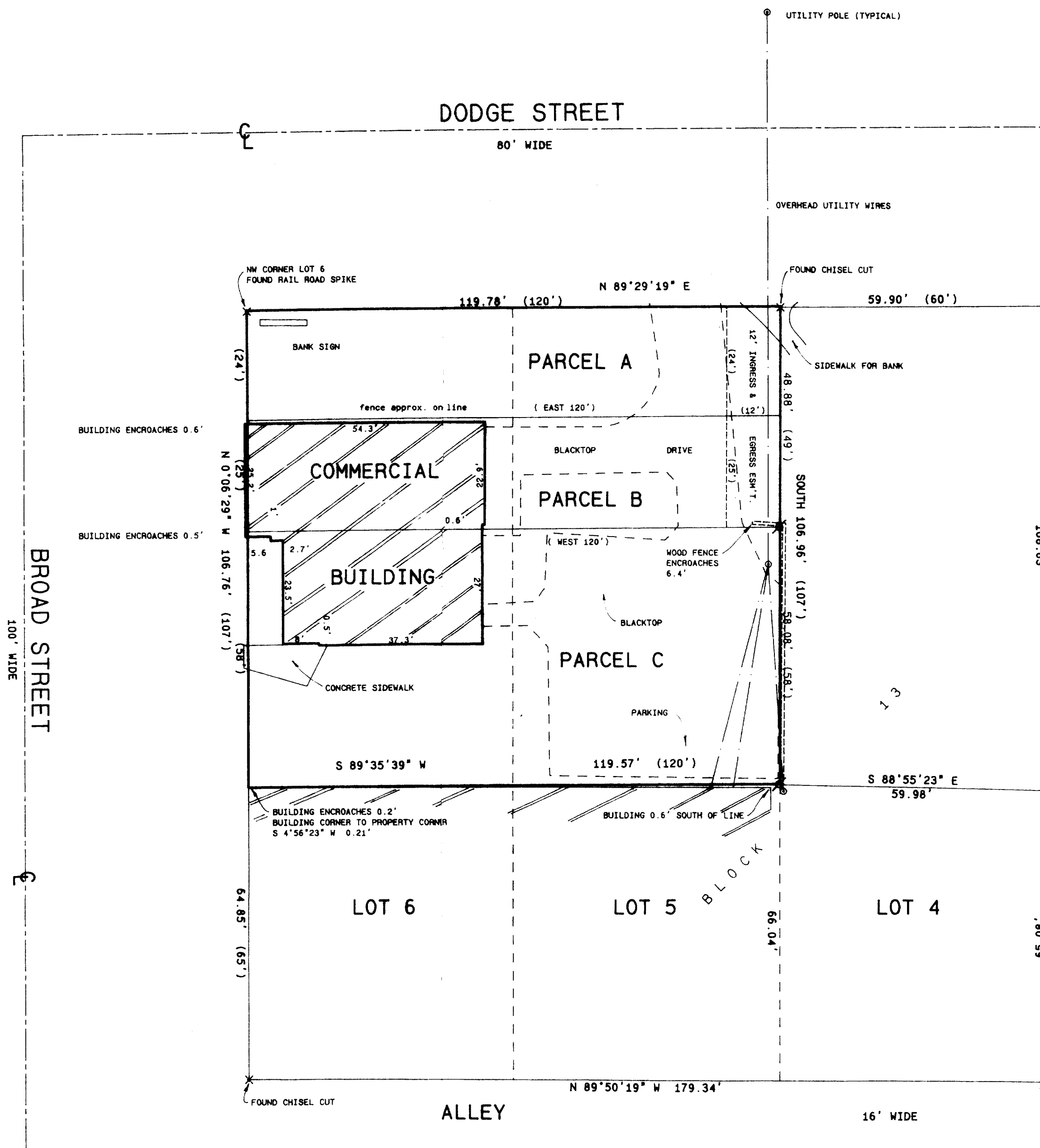
PARCEL B: A PART OF LOTS 5 AND 6, BLOCK 13, VILLAGE OF GENEVA, NOW CITY OF LAKE GENEVA, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT 24 FEET SOUTH OF THE NORTHWEST CORNER OF SAID LOT 6; RUNNING THENCE EAST PARALLEL WITH THE NORTH LINE OF SAID LOT, 120 FEET TO THE EAST LINE OF LOT 5; THENCE SOUTH ON SAID EAST LINE OF SAID LOT 5, 25 FEET; THENCE 120 FEET TO THE WEST LINE OF LOT 6; THENCE NORTH 25 FEET TO THE PLACE OF BEGINNING. TOGETHER WITH A NON-EXCLUSIVE EASEMENT FOR INGRESS AND EGRESS OVER AND ACROSS THE EAST 12 FEET OF THE NORTH 24 FEET OF SAID LOT 5.

PARCEL C: ALL THAT PART OF LOTS 5 AND 6, BLOCK 13, VILLAGE OF GENEVA (NOW CITY OF LAKE GENEVA), WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT IN THE EAST LINE OF BROAD STREET 49 FEET SOUTH OF THE NORTHWEST CORNER OF SAID BLOCK 13, RUN THENCE EAST IN A LINE PARALLEL TO THE NORTH LINE OF SAID BLOCK 13, 120 FEET TO THE EAST LINE OF LOT 5 IN SAID BLOCK 13; THENCE SOUTH IN THE EAST LINE OF SAID LOT 5, 58 FEET; THENCE WEST PARALLEL TO THE NORTH LINE OF SAID BLOCK 13, 120 FEET TO THE EAST LINE OF SAID BROAD STREET; THENCE NORTH IN THE EAST LINE OF SAID BROAD STREET, 58 FEET TO THE POINT OF BEGINNING. TOGETHER WITH A NON-EXCLUSIVE EASEMENT FOR INGRESS AND EGRESS FROM THE EAST END OF THE SUBJECT PREMISES, 12 FEET WIDE, RUNNING NORTH TO DODGE STREET.

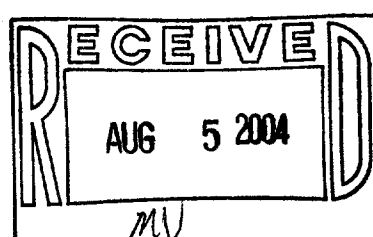
