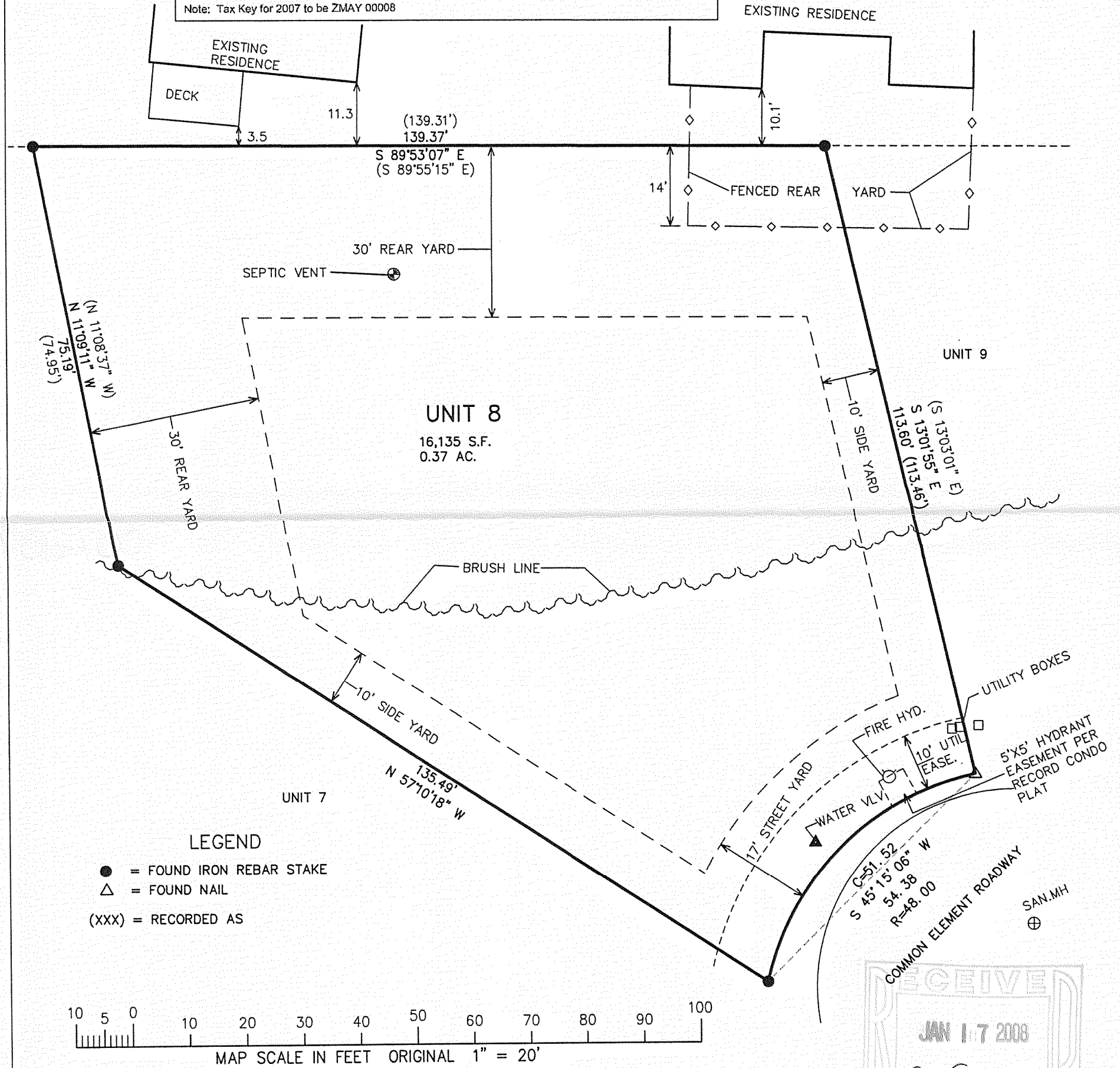

PLAT OF SURVEY

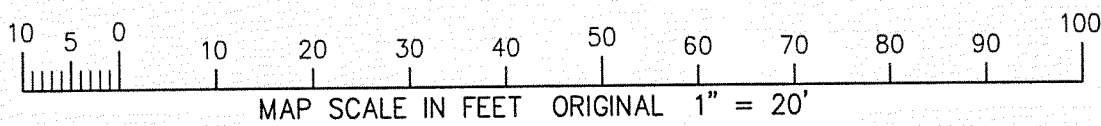

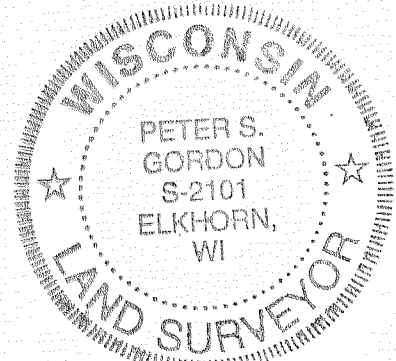
