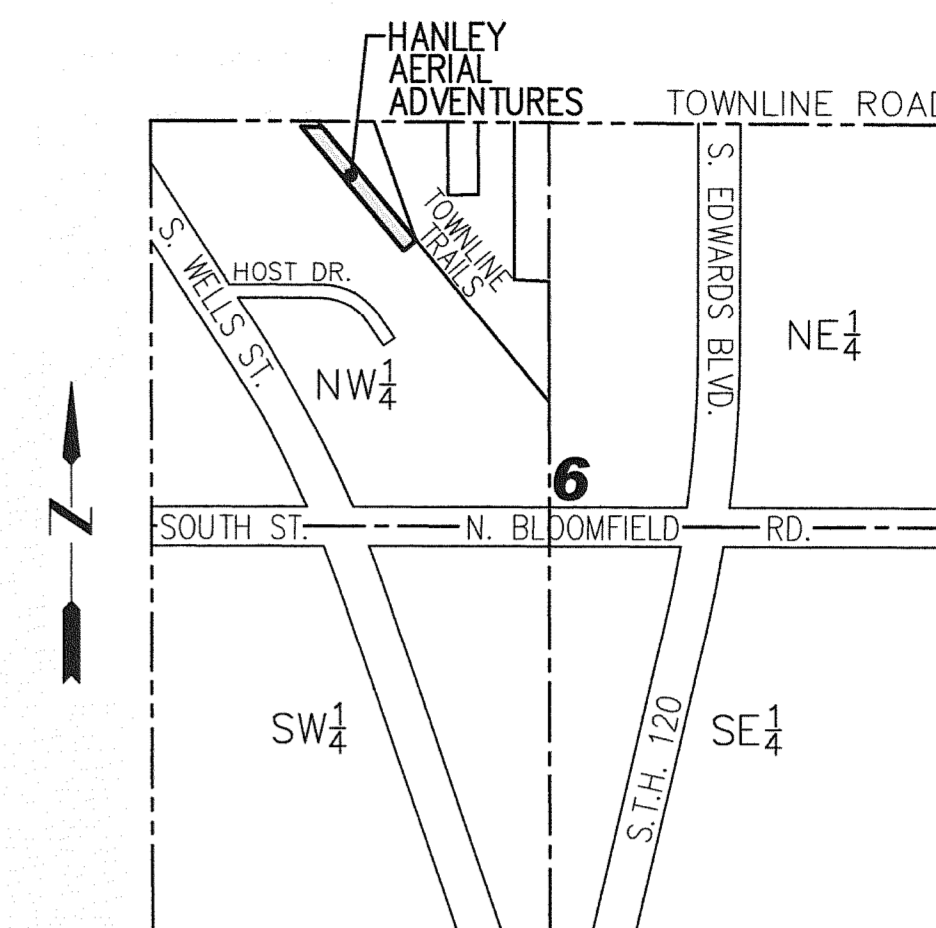


# BOUNDARY TOPOGRAPHIC SURVEY

Legal Description Tax ID# ZYUP-00144:

That part of the Northwest 1/4 of the Northwest 1/4 and the Northeast 1/4 of the Northwest 1/4 of Section 6, Township 1 North, Range 18 East of the Fourth Principal Meridian, in the City of Lake Geneva, Walworth County, Wisconsin, described as follows:

Commencing at the northwest corner of said Northwest 1/4; thence North 89°51'55" East, along the north line of said Northwest 1/4 and the centerline of Town Line Road, 1051.62 feet to the northwesterly extension of the southwesterly line of a 100 foot wide strip of land (formerly the Chicago and Northwestern Railroad right of way); thence South 39°58'33" East, along said southwesterly line, 42.98 feet to south right of way line of Townline Road and the point of beginning; thence North 89°51'55" East, along said south line, 130.24 feet to the west line of Certified Survey Map 681, as recorded in the Walworth County Register of Deeds Office, in Volume 3, of records on Page 175 and the northeasterly line of said 100 foot strip of land; thence South 39°58'33" East, along said line and the southwesterly line of Lot 9 of Townline Trails Subdivision, 915.06 feet; thence South 49°42'39" West 100.00 feet to the southwesterly line of said 100 foot wide strip of land (formerly the Chicago and Northwestern Railroad right of way); thence North 39°58'33" West, along said southwesterly line, 999.04 feet to the point of beginning.

This parcel contains 2.200 acres or 95,704 square feet, more or less.

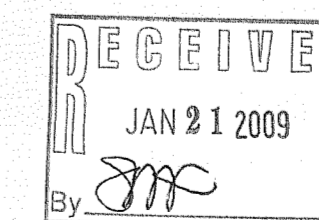

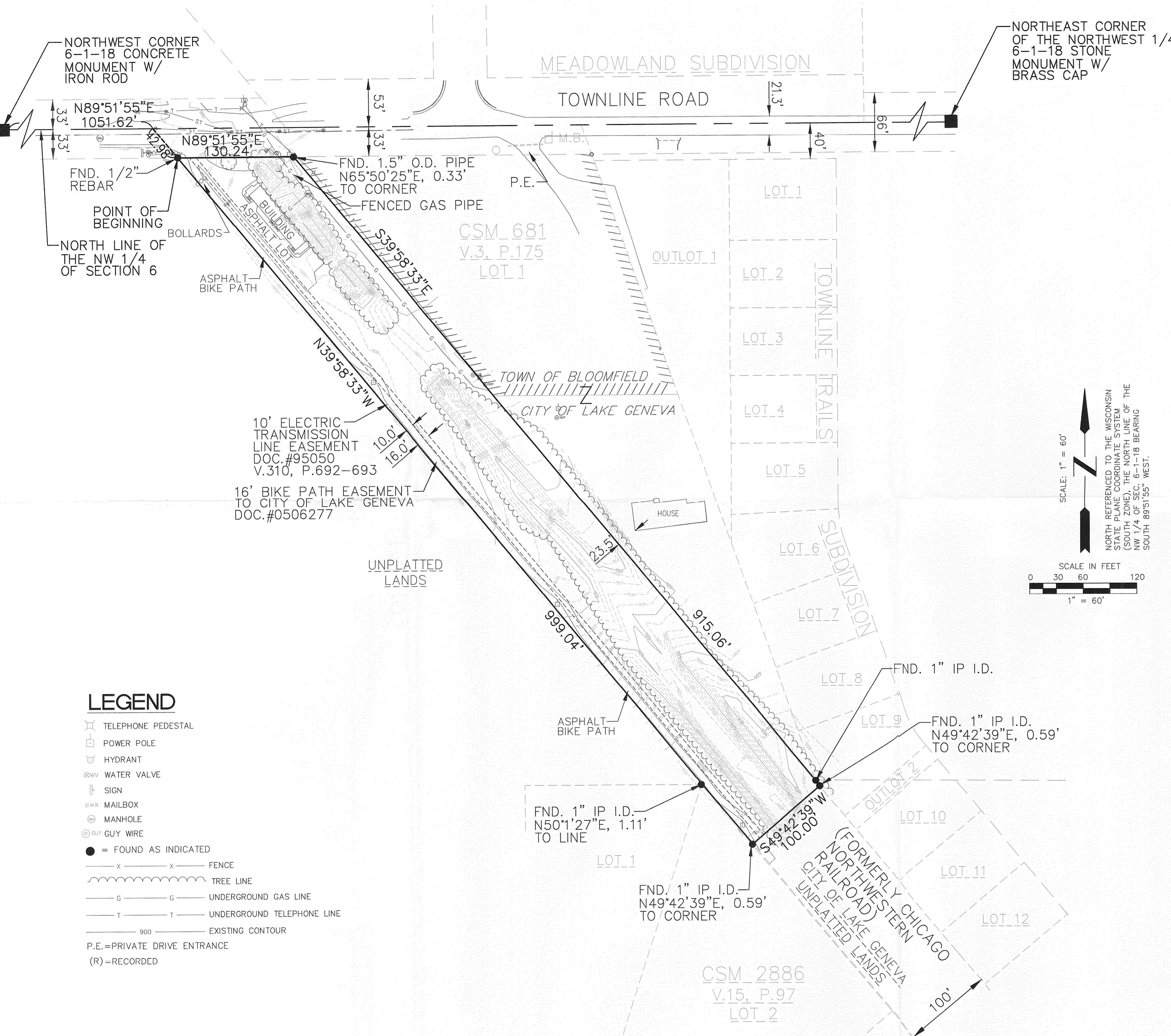
