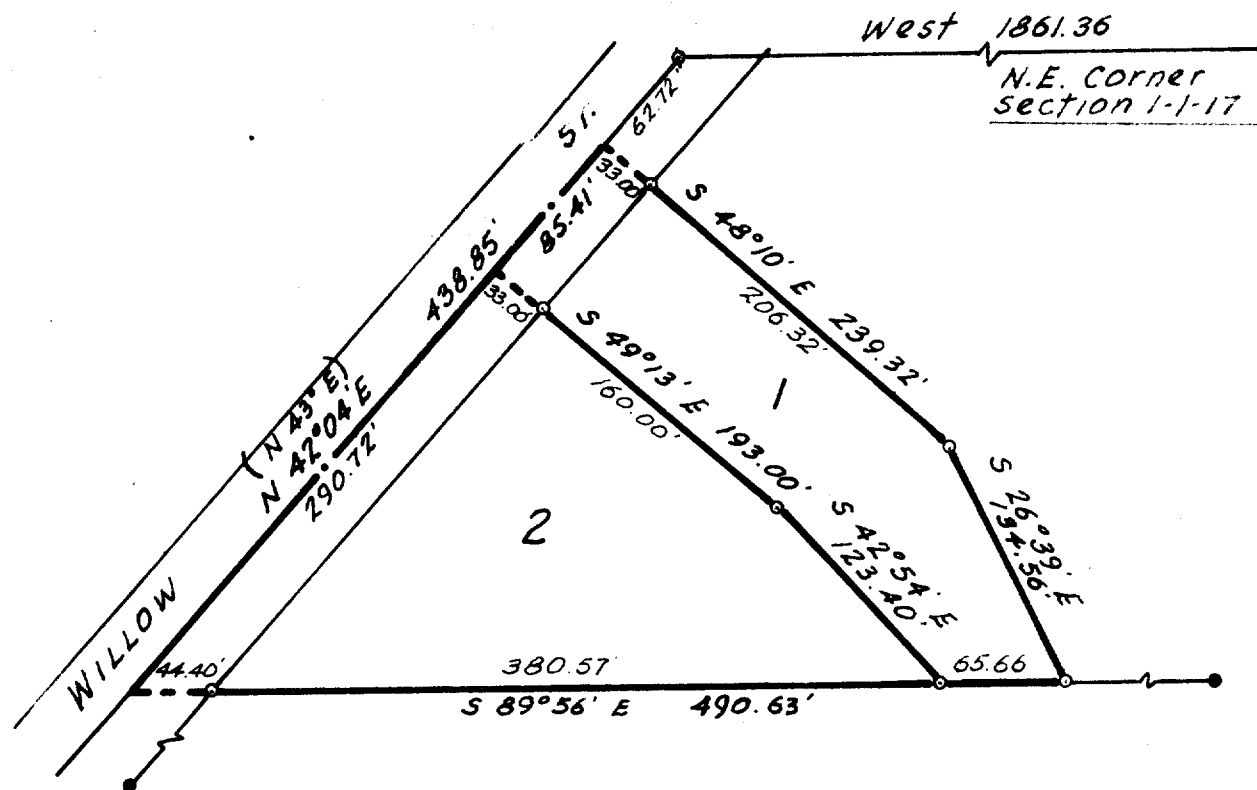

DESCRIPTION OF

Two parcels of land located in the Northeast $\frac{1}{4}$ of Section 1,
T 1 N, R 17 E, City of Lake Geneva, Walworth County, Wisconsin
and described as follows:

PARCEL 1

Commencing at the Northeast corner of said Section 1, thence
west 1861.36 feet along the North line of said Section 1 to the
centerline of Willow St.; thence S $42^{\circ}04'$ W 62.72 feet along said
centerline to the place of beginning; thence S $48^{\circ}10'$ E 239.32 feet;
thence S $26^{\circ}39'$ E 134.56 feet; thence N $89^{\circ}56'$ W 65.66 feet;
thence N $42^{\circ}54'$ W 123.40 feet; thence N $49^{\circ}13'$ W 123.00 feet to
said centerline; thence N $42^{\circ}04'$ E 85.41 feet along said centerline
to the place of beginning.

PARCEL 2

Commencing at the Northeast corner of said Section 1, thence
West 1861.36 feet along the North line of said Section 1 to the
centerline of Willow St.; thence S $42^{\circ}04'$ W 148.13 feet along
said centerline to the place of beginning; thence S $49^{\circ}13'$ E
193.00 feet; thence S $42^{\circ}54'$ E 123.40 feet; thence N $89^{\circ}56'$ W
424.97 feet to said centerline; thence N $42^{\circ}04'$ E 290.72 feet
along said centerline to the place of beginning.
