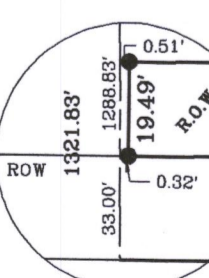
Detail 1

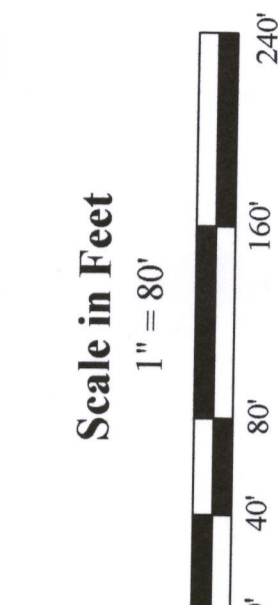
Detail 2
