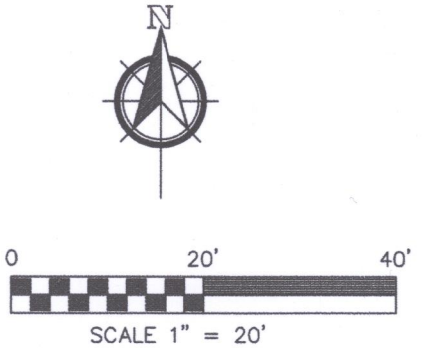
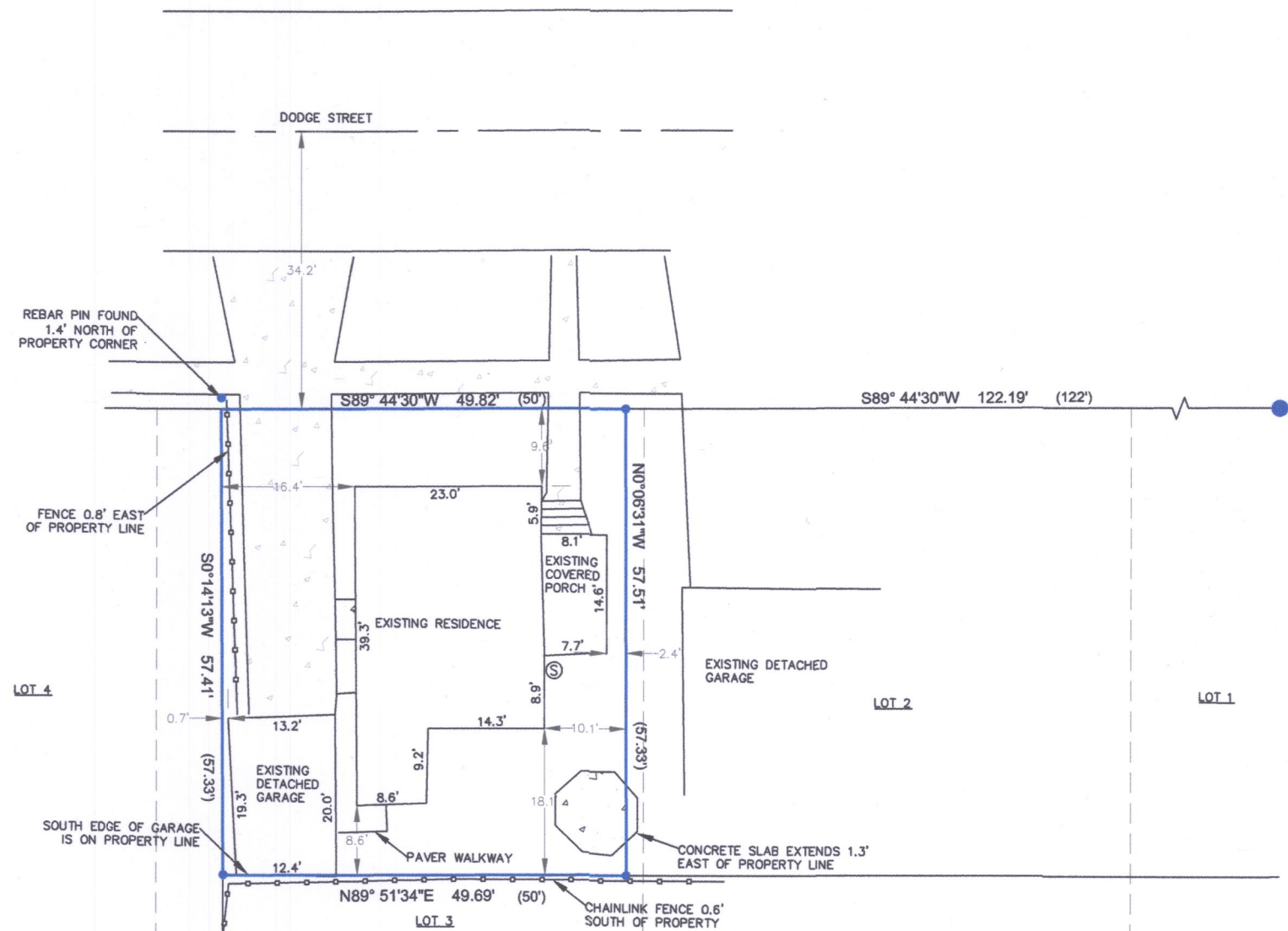


PLAT OF SURVEY

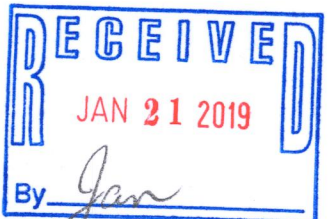


LEGEND
