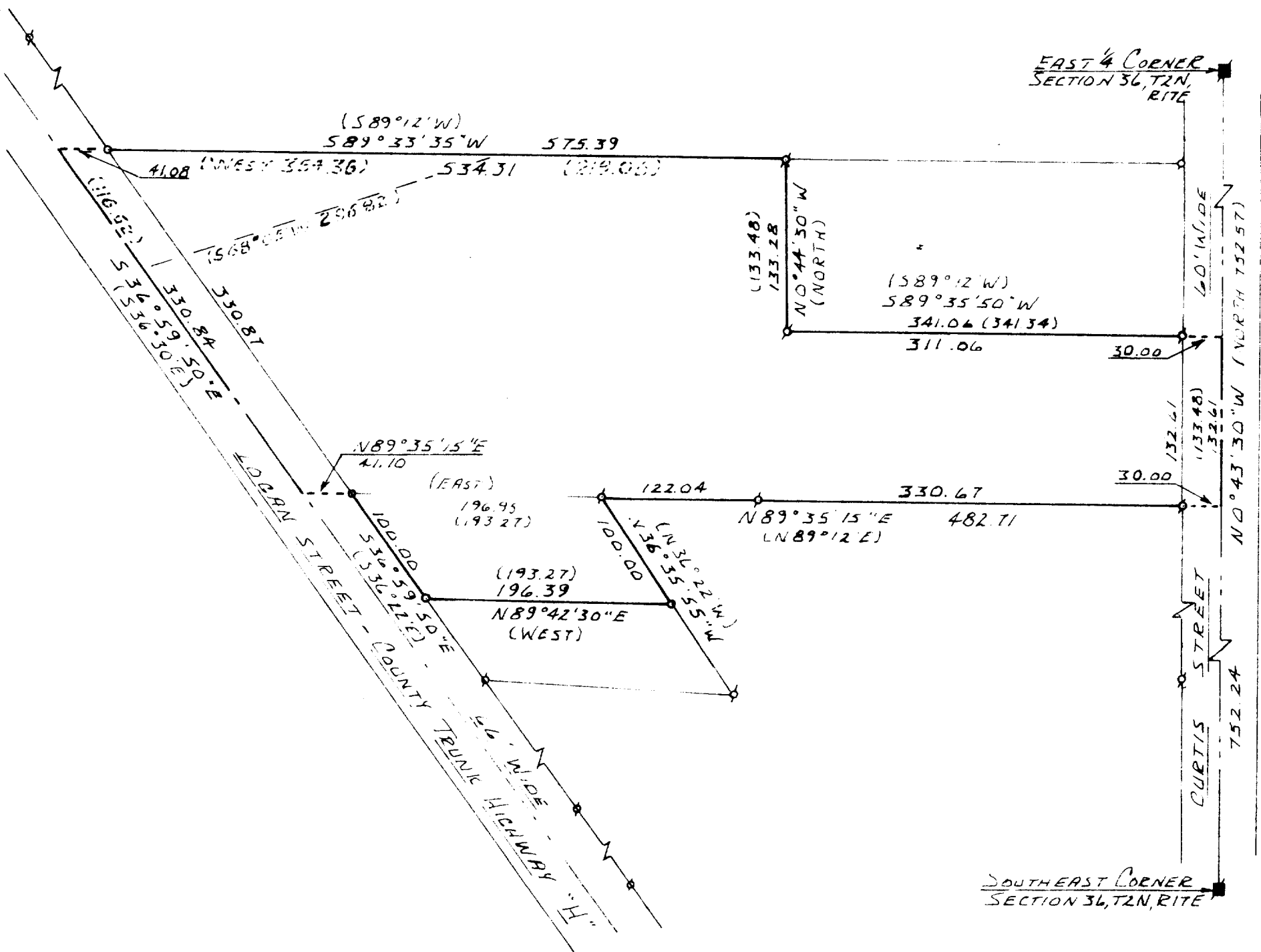

## PLAT OF SURVEY OF

A PARCEL OF LAND LOCATED IN THE SOUTHEAST 1/4 OF SECTION 36, T2N, R17E, WALWORTH COUNTY, WISCONSIN, AND DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHEAST CORNER OF SAID SECTION 36; THENCE  $N 0^{\circ} 43' 30'' W$  752.24 FEET ALONG THE EAST LINE OF THE SOUTHEAST 1/4 OF SAID SECTION TO THE PLACE OF BEGINNING; THENCE  $S 89^{\circ} 35' 50'' W$  341.06 FEET; THENCE  $N 0^{\circ} 44' 30'' W$  133.28 FEET; THENCE  $S 89^{\circ} 33' 35'' W$  575.39 FEET TO THE CENTERLINE OF COUNTY TRUNK HIGHWAY "H"; THENCE  $S 36^{\circ} 59' 50'' E$  330.84 FEET ALONG SAID CENTERLINE; THENCE  $N 89^{\circ} 35' 15'' E$  41.10 FEET TO THE EAST LINE OF SAID HIGHWAY; THENCE  $S 36^{\circ} 59' 50'' E$  100.00 FEET ALONG SAID EAST LINE; THENCE  $N 89^{\circ} 42' 30'' E$  196.39 FEET; THENCE  $N 36^{\circ} 35' 55'' W$  100.00 FEET; THENCE  $N 89^{\circ} 35' 15'' E$  482.71 FEET TO THE EAST LINE OF SAID SOUTHEAST 1/4; THENCE  $N 0^{\circ} 43' 30'' W$  ALONG SAID EAST LINE TO THE PLACE OF BEGINNING. CONTAINING 4.32 ACRES.

NOTE: THE BEARING OF THE EAST LINE OF THE SOUTHEAST 1/4 OF SECTION 36 IS  $N 0^{\circ} 43' 30'' W$  AS REFERENCED TO THE WISCONSIN COORDINATE SYSTEM, SOUTH ZONE.

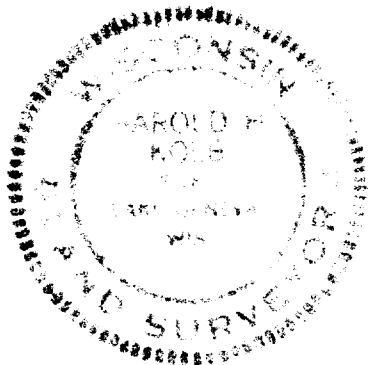
