as follows:

Anation 1. A potition having been filed for direct ememotion by Reafe & Associates, Inc., a Wisconsin comporation, in conformace with the Wisconsin Statutes, Section 66.021(12), dated September 22, 1978 and said potition being further adopted and ratified by Burton V. being and Bileon Subse, his wife, Land Contract Purchasers of the west estate described hereinbelow, and it being in the bust interests of the City of Lake Geneva to grant with antificient described evicated that the following described pointies to amount to the City of Lake Geneva and attached to bed No. 2 thereof:

Let 19 of Caylon Court Estates, according to the recorded Plat of eaid Subdivision, recorded in Tolume 12 of Plats on Pages 12 and 13 as the same appears in the Office of the Register of Deeds in and for Walmorth County, Viaconsin.
