AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF LAKE GENENVA and ESTABLISHING ZONING

ORDINANCE NO.

The City Council of Lake Geneva, Wisconsin in duly called session does ordain as follows:

SECTION 1: Territory Annexed. In accordance with the provisions of Section 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on the ___, 1980, signed by all of the property 15th. day of August owners of the land in area within such territory and there being no electors residing within the land in area to be annexed, the following described territory in the Town of Lyons, Walworth County, Wisconsin, is hereby annexed to the City of Lake Geneva, Walworth County, Wisconsin:

A parcel of land located in the NW% of the SW% of Section 31, Town 2 North, Range 18 East, Walworth County, Wisconsin, described as follows: Begin at the West 1/4 corner of said Section 31; thence N. 89° 50' 07" E. 659.85'; thence S. 0° 43' 28" E. 329.39'; thence S. 89° 55' 46" W. 466.86'; thence N. 0° 43' 28" W. 59.97'; thence S. 89° 55' 46" W. 193.00'; thence N. 0° 43' 28" W. 268.34' to the point of beginning. Said parcel contains 4.72 acres of land, more or less.

SECTION II: Effect of Annexation. From and after the date of this ordinance the territory described in Section I shall be a part of the City of Lake Geneva, for any and all purposes provided by law, and all persons coming within such territory shall be subject to all ordinances, rules and regulations governing the City of Lake Geneva.

SECTION III: Zoning Classification. The Plan Commission is directed to prepare an amendment to the zoning ordinances and the comprehensive zoning ordinances of the City setting forth the permanent classification and regulations for the Residential District "3" (R-3).

SECTION IV: Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION V: Effective Date. This ordinance shall take effect upon passage and publication as provided by law.
