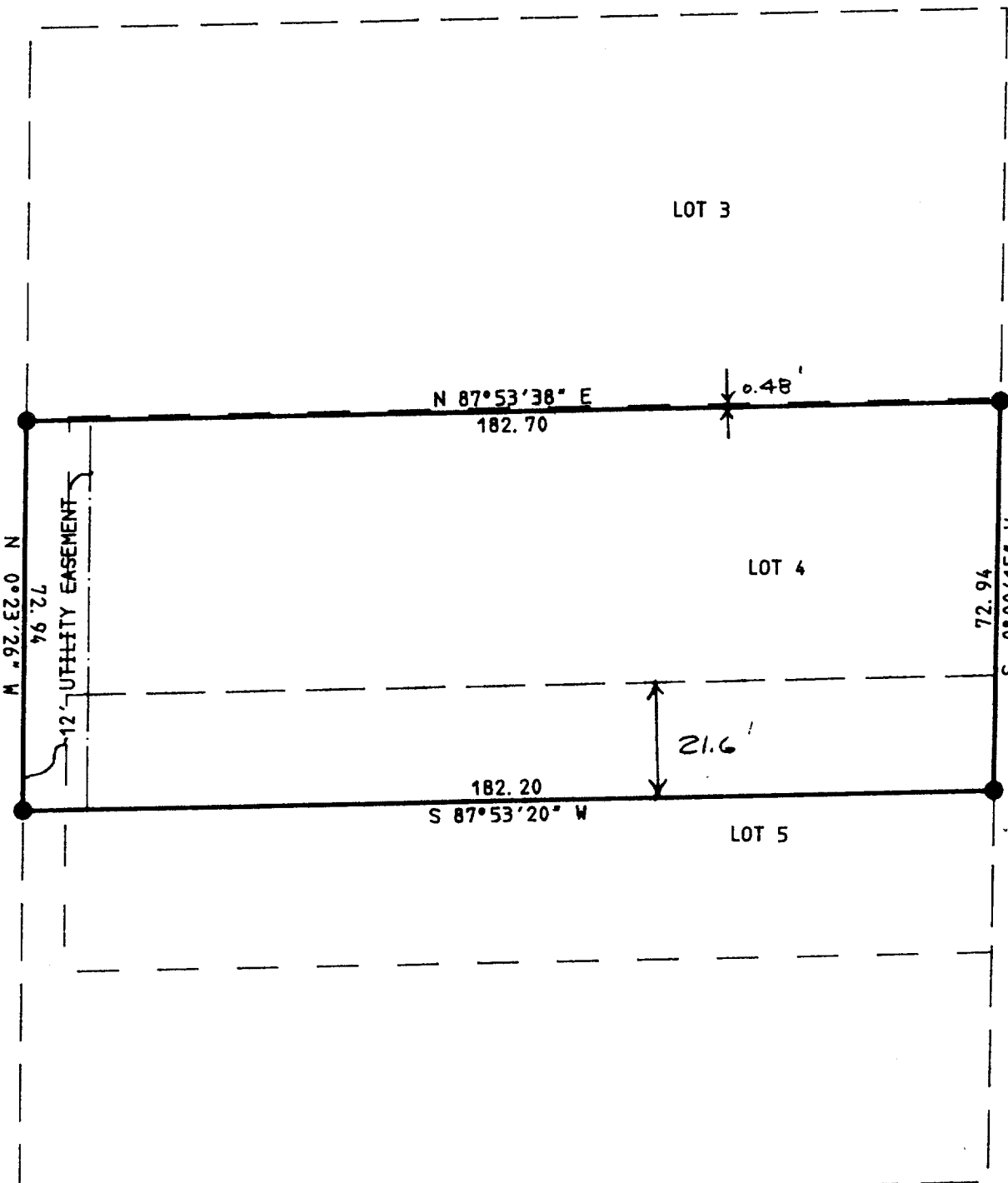
# PLAT OF SURVEY

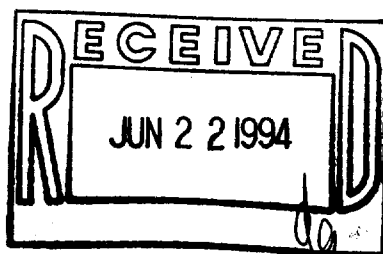
