A parcel of land described in a Warranty Deed recorded April 8, 2008 as Document No. 733701 as shown below:

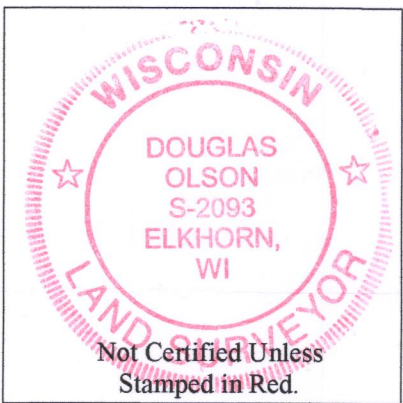

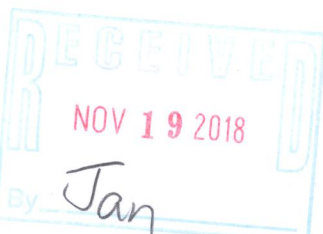
