

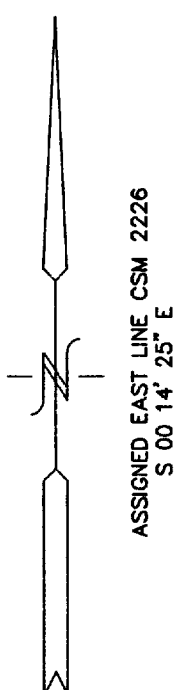

PLAT OF SURVEY LOTS 1 & 2 OF CERTIFIED SURVEY MAP NO. 2226

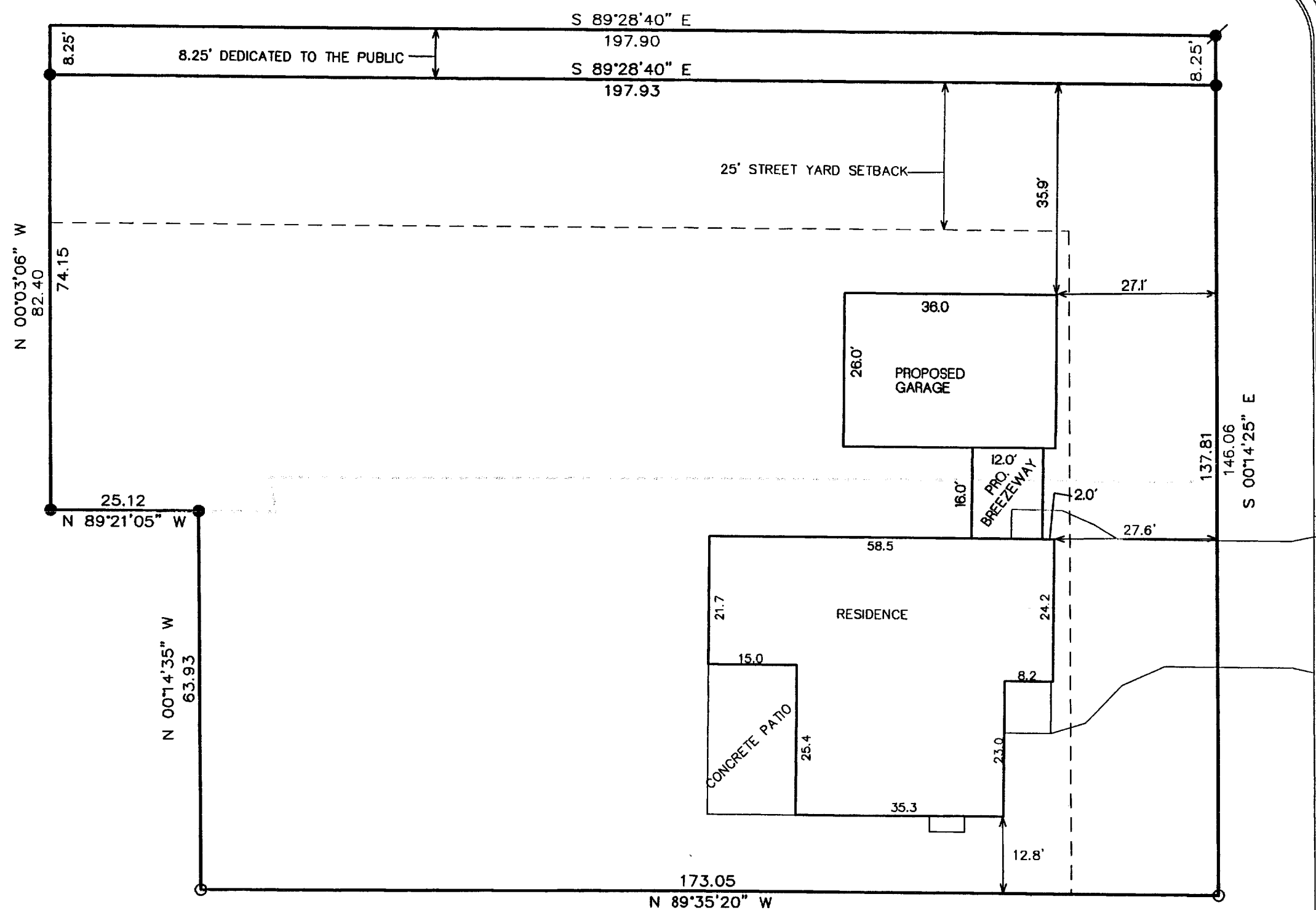

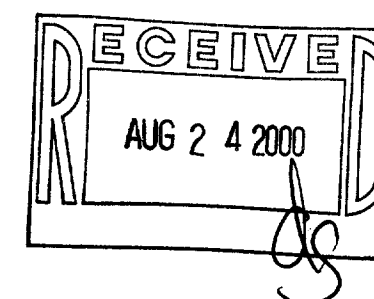

60' WIDE

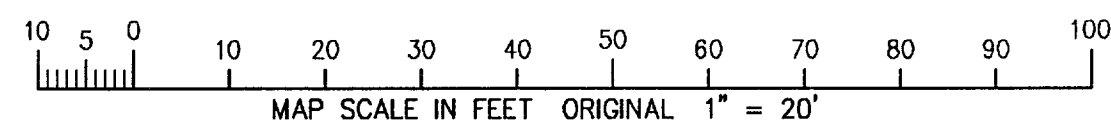
