MARCH 19, 2005 I PERFORMED A SURVEY ON A PORTION OF LOT 2 OF BLOCK 4. I DISCOVERED AND AGREED WITH A SURVEY BY LLOYD L. JENSEN DATED JULY 1953 THAT THE EAST SIDE OF BLOCK 4 IS 12.46' LONGER THAN RECORD. MY FIELD DATA FROM THIS SURVEY AGREES WITH A GEORGE T. DUNHAM SURVEY DATED JULY 1, 1963, WHICH HE PRORATED THE NORTH LINE OF THE BLOCK LINE BECASUSE IT IS 4.97' LONGER THAN RECORD. MY FIELD DATA ALSO AGREES WITH DUNHAM THAT THE WEST LINE OF BLOCK 4 IS 8.31' LONGER THAN RECORD. I ALSO AGREE WITH A THIRD SURVEY BY WATERMAN, FUGE & ASSOCIATES DATED APRIL 8, 1959, THAT THE SOUTH LINE OF BLOCK 4 IS 8.27' LONGER THAN RECORD. I BELIEVE THERE IS A SCRIBNER'S ERROR ON THE ORIGINAL PLAT OF THE DISTANCE OF 328 LINKS (216.48') OF THE WEST LINE OF LOT 6, BLOCK 4. 
