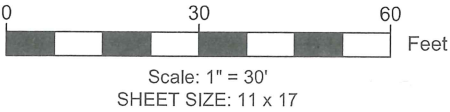


PLAT OF SURVEY & SITE PLAN

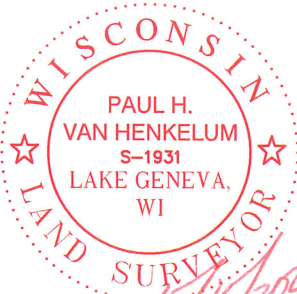
