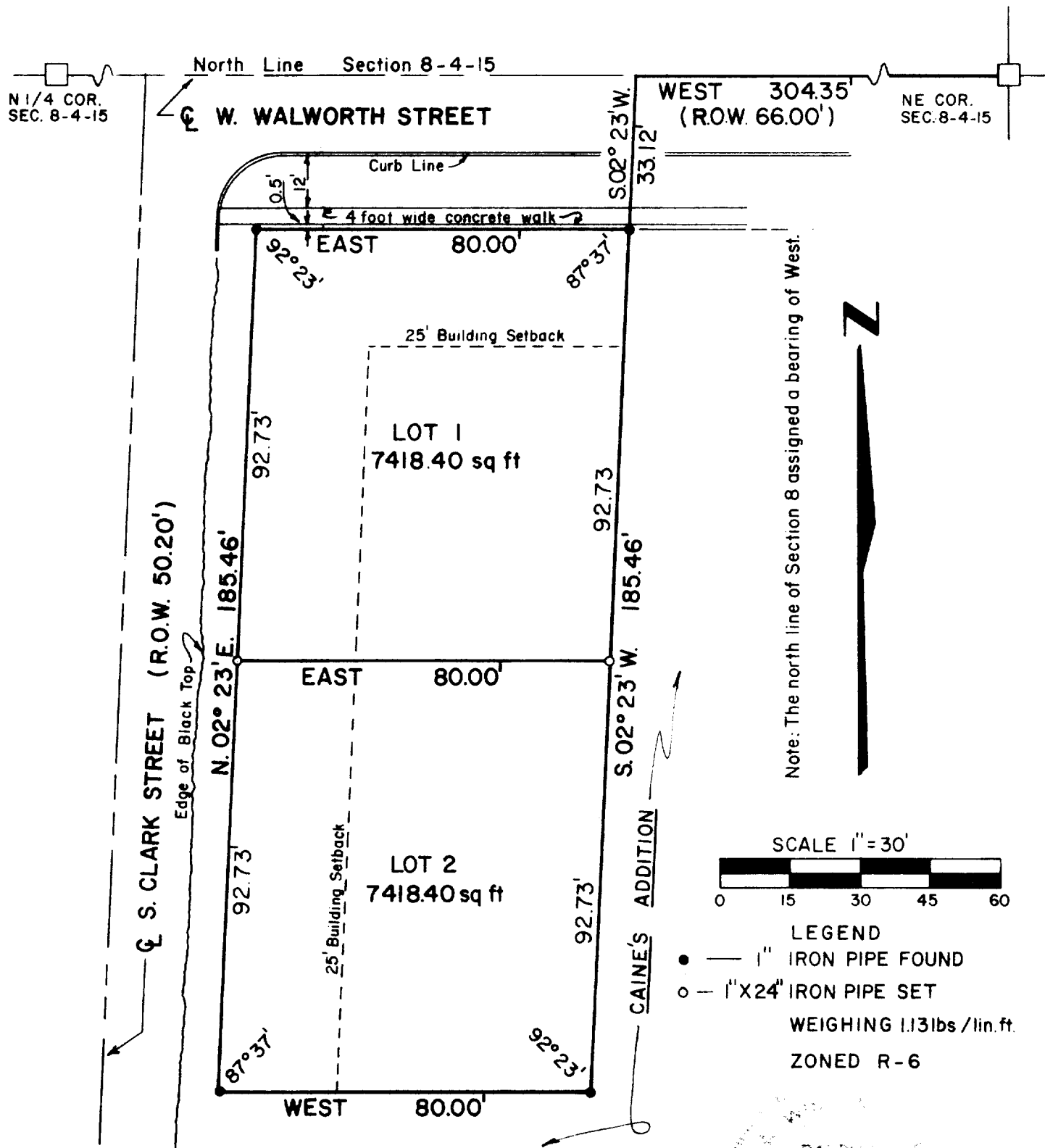

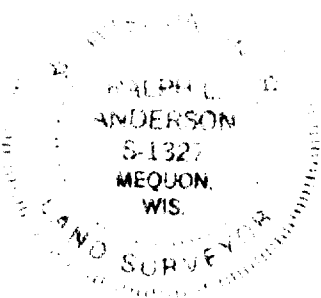

### DESCRIPTION

A PARCEL OF LAND LOCATED IN THE NE 1/4 OF THE NE 1/4 OF SECTION 8, T 4 N, R 15 E, CITY OF WHITEWATER, WALWORTH COUNTY, WISCONSIN; PREVIOUSLY DESCRIBED AS THE WEST 80 FEET OF LOT 2, BLOCK 1 OF CAINE'S ADDITION TO THE CITY OF WHITEWATER; MORE PARTICULARLY DESCRIBED AS FOLLOWS:  
COMMENCING AT THE NE CORNER OF SECTION 8 AS RE-ESTABLISHED BY TIES FROM THE WALWORTH COUNTY SURVEYOR'S OFFICE; THENCE WEST---304.35 FEET ALONG THE NORTH LINE OF SECTION 8;  
THENCE S 02° 23' W ---33.12 FEET TO THE POINT OF BEGINNING;  
THENCE CONTINUING S 02° 23' W---185.46 FEET; THENCE WEST---80.00 FEET TO THE EAST LINE OF SOUTH CLARK STREET;  
THENCE N 02° 23' E---185.46 FEET ALONG SAID EAST LINE TO THE SOUTH LINE OF WEST WALWORTH STREET; THENCE EAST---80.00 FEET ALONG SAID SOUTH LINE TO THE POINT OF BEGINNING; CONTAINING 0.34 ACRES.
