

## PARCEL 1

BEGINNING AT THE SW CORNER OF OUTLOT 15 IN S.C. HALL'S ADDITION TO THE VILLAGE, NOW CITY, OF WHITEWATER, WALWORTH COUNTY, WISCONSIN, AND RUNNING THENCE N 14 CHS. AND 56 LKS. TO THE WISCONSIN CENTRAL RAILROAD AS SHOWN ON THE RECORDED PLAT OF SAID ADDITION; THENCE S'LY 8 CHS AND 87 LKS. ALONG THE LINE OF SAID RAILWAY: THENCE SWLY 8 CHS. AND 87 LKS. TO THE PLACE OF BEGINNING.

### PARCEL 2:

A PARCEL OF LAND LOCATED IN SECTION 3, T4N, R15E, WALWORTH COUNTY, WISCONSIN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT A POINT ON THE SOUTH LINE OF CLAY STREET, 289 74 FEET EAST OF THE WEST SECTION LINE OF SAID SECTION 3; THENCE SOUTH, ON A LINE PARALLEL TO THE WEST LINE OF SAID SECTION, TO THE SOUTH LINE OF SAID SECTION 3; THENCE WEST ON THE SOUTH LINE OF SAID SECTION 3, 100 FEET TO A POINT; THENCE NORTH ON A LINE PARALLEL TO THE WEST LINE OF SAID SECTION 3, TO THE SOUTH LINE OF CLAY STREET; THENCE EAST, ON THE SOUTH LINE OF CLAY STREET, 100 FEET, TO THE PLACE OF BEGINNING

A PARCEL OF LAND LOCATED IN THE SW 1/4 OF THE SW 1/4 OF SECTION 3, T4N, R15E, CITY OF WHITEWATER, WALWORTH CO., WISCONSIN, MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO-WIT; THAT PART OF THE ABANDONED WISCONSIN CENTRAL RAILROAD RIGHT-OF-WAY LYING SOUTHERLY OF THE SOUTH LINE OF CLAY STREET AND NORTHERLY OF THE THE EXTENSION WESTERLY OF THE NORTH LINE OF OUTLOT 17 OF S.C.
