

DESCRIPTION OF PARCEL SURVEYED

A parcel of land located in the SW 1/4 of the SW 1/4 of Section 4, T.4 N., R.15 E., City of Whitewater, Walworth County, Wisconsin, more particularly described as follows:

Commencing at the SW Corner of said Section 4; thence N 00° 01' 50" W along the West line of said Section 4, 453.62 feet to the centerline of the mainline tracks of the C.M. ST. P. and P. R.R.; thence N 50° 43' 12" E along said centerline, 223.11 feet; thence S 37° 39' 22" E, 33.00 feet to a 1" iron pipe set and the point of beginning of this description;

Thence continuing S 37° 39' 22" E, 68.24 feet to a 1" iron pipe set at the NW Corner of Lot 5, Block 7, Tripps Addition to the Village of (now City) Whitewater;
 Thence N 50° 42' 00" E along the north line of said Block 7, 462.00 feet to a 1" iron pipe set at the NE corner of Lot 1, of said Block 7;
 Thence N 37° 39' 22" W, 58.58 feet to a 1" iron pipe set;
 Thence S 54° 29' 18" W, 145.72 feet to a 1" iron pipe set;
 Thence S 50° 42' 18" W, 316.33 feet to the point of beginning of this description.

The above described parcel contains 30,804 square feet and is subject to existing easements with the City of Whitewater for Storm Sewer lines and subject to existing easements or agreements with Electric Utility Companies for overhead power lines and poles.

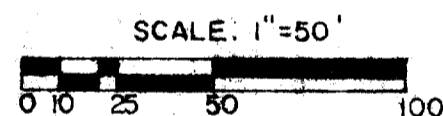
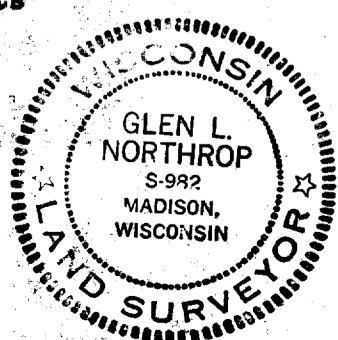
