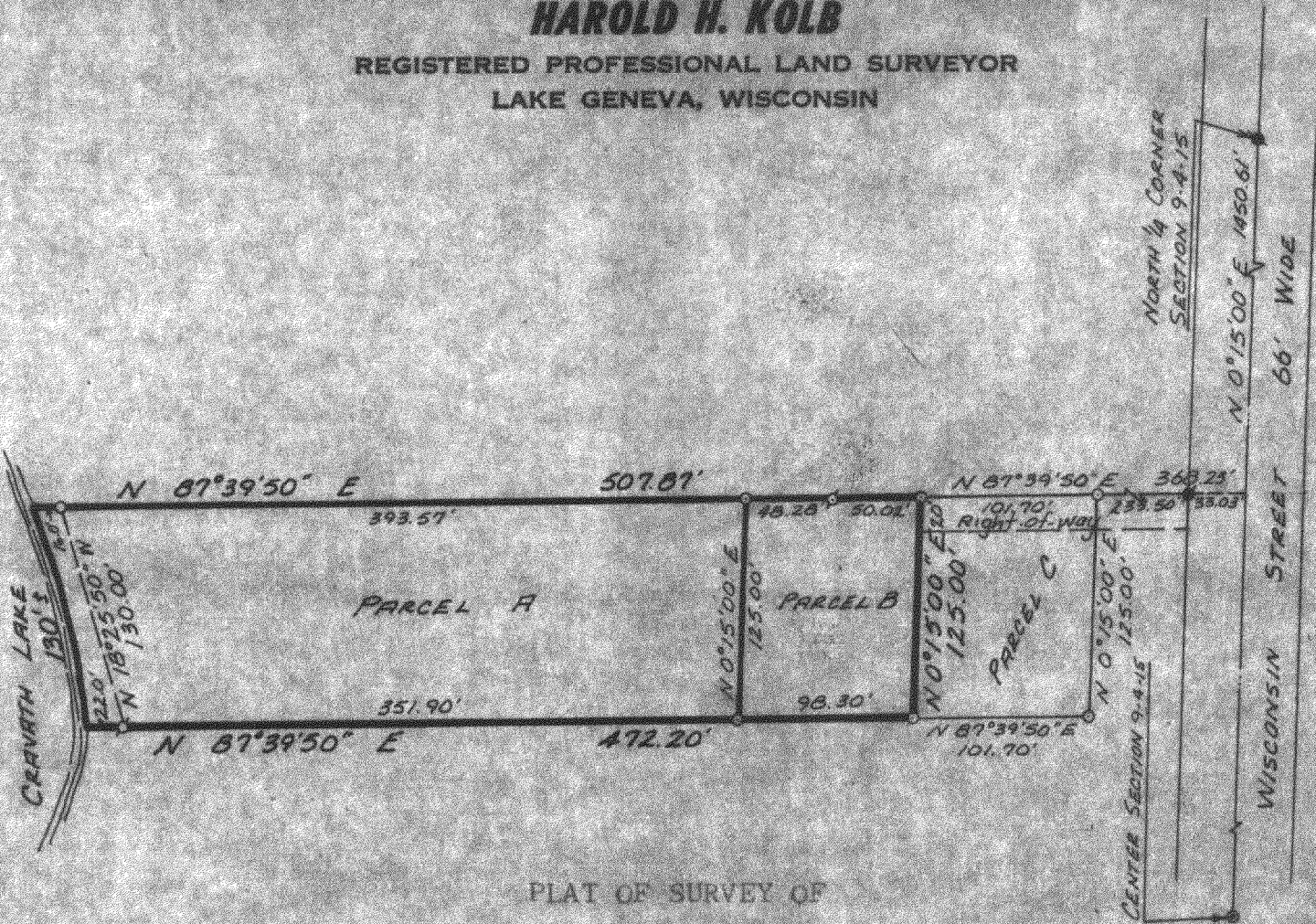

PLAT OF SURVEY OF

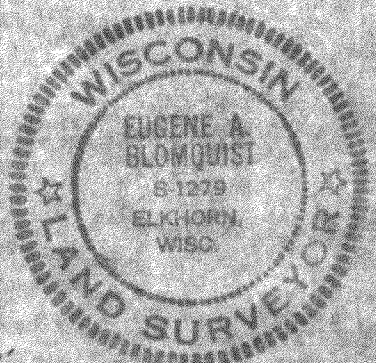
Two parcels of land located in the Northwest 1/4 of Section 9, T 4 N, R 15 E, City of Whitewater, Walworth County, Wisconsin and described as follows:
PARCEL A: A lot line adjustment for Parcel B; Commencing at the North 1/4 Corner of said Section 9; thence S 0°15'00" W 1450.61 feet; thence S 87°39'50" W 466.53 feet to the place of beginning; thence S 0°15'00" W 125.00 feet; thence S 87°39'50" W 373.90 feet to the Shoreline of Cravath Lake; thence Northwesterly along said Shoreline 130 ± feet to a point that is S 87°39'50" W 409.57 feet from the place of beginning; thence N 87°39'50" E 409.57 feet to the place of beginning. Containing 1.13 acres.
PARCEL B: Commencing at the North 1/4 Corner of said Section 9; thence S 0°15'00" W 1450.61 feet; thence S 87°39'50" W 368.23 feet to the place of beginning; thence S 0°15'00" W 125.00 feet; thence S 87°39'50" W 98.30 feet; thence N 0°15'00" E 125.00 feet; thence N 87°39'50" E 98.30 feet to the place of beginning. Containing 0.28 acres.
PARCEL C: Commencing at the North 1/4 Corner of said Section 9; thence S 0°15'00" W 1450.61 feet; thence S 87°39'50" W 266.53 feet to the place of beginning; thence S 0°15'00" W 125.00 feet; thence S 87°39'50" W 101.70 feet; thence N 0°15'00" E 125.00 feet; thence N 87°39'50" E 101.70 feet to the place of beginning. Containing 0.29 acres.
 Also a right-of-way 20.00 feet wide for ingress and egress described as follows: Commencing at the North 1/4 Corner of said Section 9; thence S 0°15'00" W 1450.61 feet; thence S 87°39'50" W 33.03 feet to the place of beginning; thence S 0°15'00" W 20.00 feet; thence S 87°39'50" W 335.20 feet; thence N 0°15'00" E 20.00 feet; thence N 87°39'50" E 335.20 feet to the place of beginning.
