

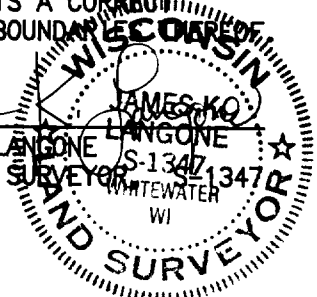

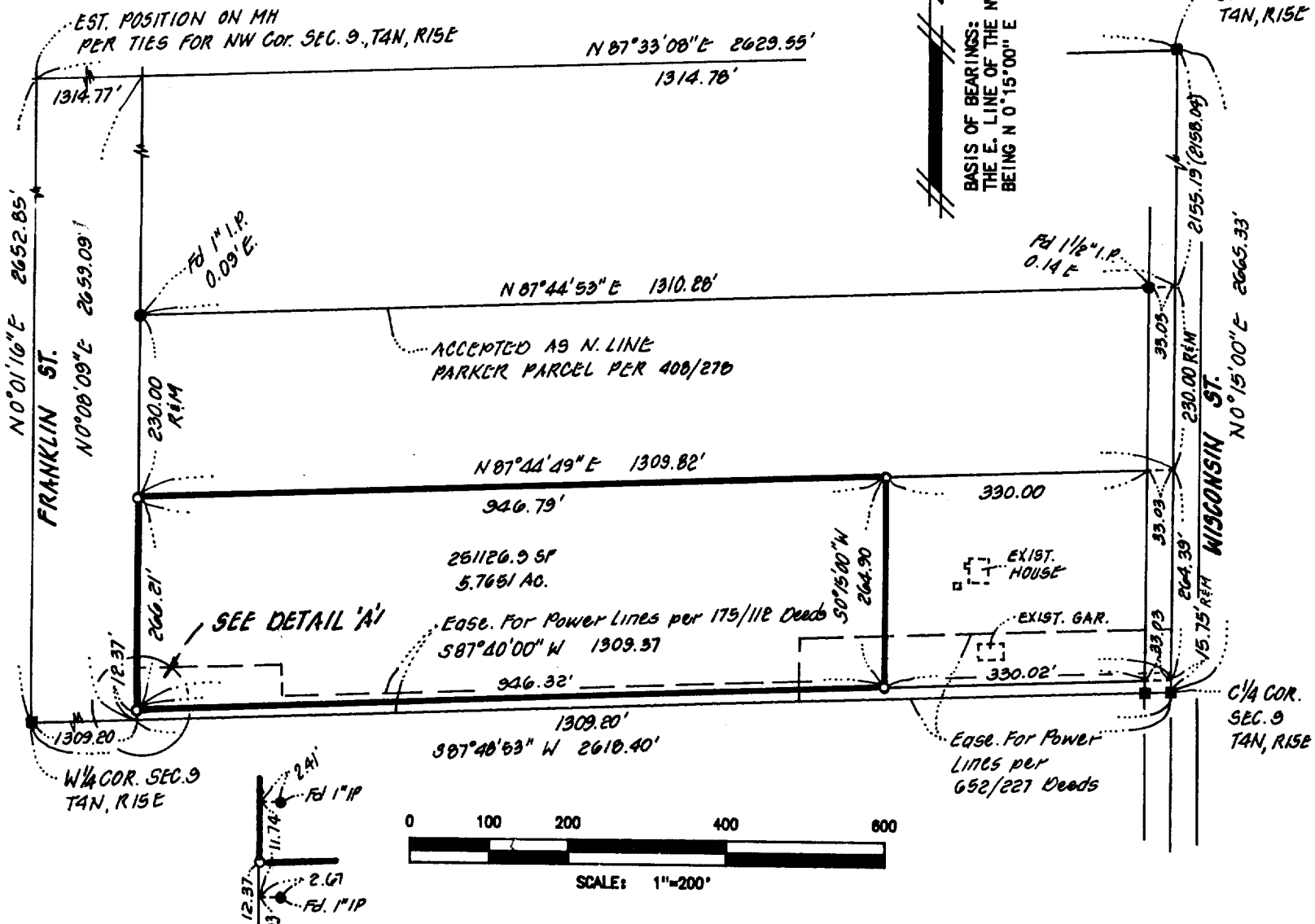
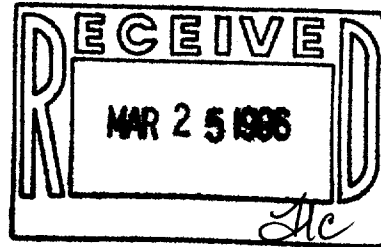

LEGAL DESCRIPTION

BEING A PORTION OF THE SE 1/4 OF THE NW 1/4, SECTION 9, T4N, R15E, IN THE CITY OF WATERWATER, WALWORTH COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:

COMMENCING AT THE SE COR. OF THE NW 1/4, SEC. 9; THENCE N 0°15'00" E, ALONG THE E. LINE OF SAID NW 1/4, 15.75 FEET, TO THE SE COR. OF THAT PARCEL CONVEYED TO CLARENCE J. & CATHERINE I. BIGELOW, BY DOCUMENT RECORDED IN VOL. 500 OF DEEDS, PAGE 922, RECORDS OF WALWORTH COUNTY; THENCE S 87°40'00" W, ALONG THE S. LINE OF SAID BIGELOW PARCEL, 383.05 FEET, TO THE "TRUE POINT OF BEGINNING"; THENCE CONTINUING ALONG SAID S. LINE, S 87°40'00" W, 948.32 FEET, TO THE SW COR. OF SAID BIGELOW PARCEL, SAID POINT BEING ON THE W. LINE OF THE SE 1/4 OF THE NW 1/4 OF SEC. 9; THENCE N 0°08'09" E, ALONG THE W. LINES OF SAID BIGELOW PARCEL AND SAID SE 1/4, 266.21 FEET, TO THE SW CORNER OF THAT PARCEL CONVEYED TO BRUCE R. & THERESA E. PARKER, BY A WARRENTY DEED RECORDED IN VOL. 408 OF RECORDS, PAGE 278; THENCE N 87°44'49" E, ALONG THE S. LINE OF SAID PARKER PARCEL, 946.79 FEET; THENCE S 0°15'00" W, PARALLEL TO THE E. LINE OF SAID NW 1/4, SEC. 9, 264.90 FEET, TO THE "TRUE POINT OF BEGINNING".
