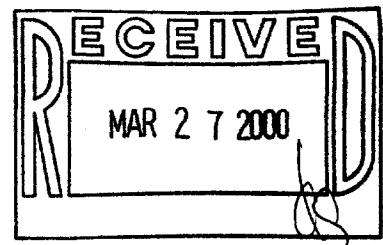


LEGAL DESCRIPTION:

F. WINDOW AND FORMERLY BY ED. ENGEBRETSON AND RUNNING THENCE E'LY AT RIGHT ANGLES TO SAID STREET, TO THE CENTER OF WHITEWATER CREEK; THENCE N'LY ALONG THE CENTER OF SAID CREEK, TO THE COUNTY LINE; THENCE E., ALONG SAID COUNTY LINE, TO A POINT 234 FEET W. OF THE NW CORNER OF LAND FORMERLY OWNED BY R. A. STRAUSSMAN AND SOLD TO WIM JOHNSON AND GEORGE GILLER; THENCE S'LY, AT RIGHT ANGLES TO SAID COUNTY LINE, TO THE CENTER OF SAID CREEK; THENCE N'LY, ALONG THE CENTER OF SAID CREEK, TO THE NE CORNER OF LAND FORMERLY OWNED BY HARRY KING; THENCE N'LY, ALONG SAID KING'S N. LINE, TO THE CENTER OF FREMONT ST; THENCE N'LY, TO THE PLACE OF "BEGINNING".

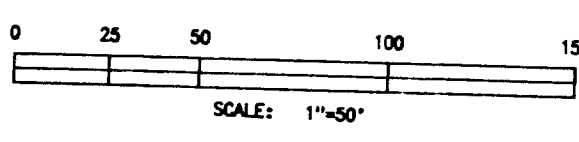
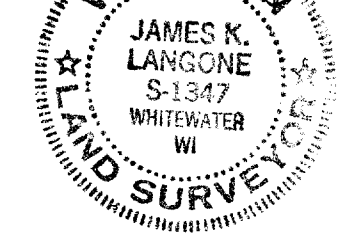
