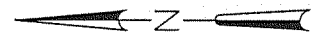
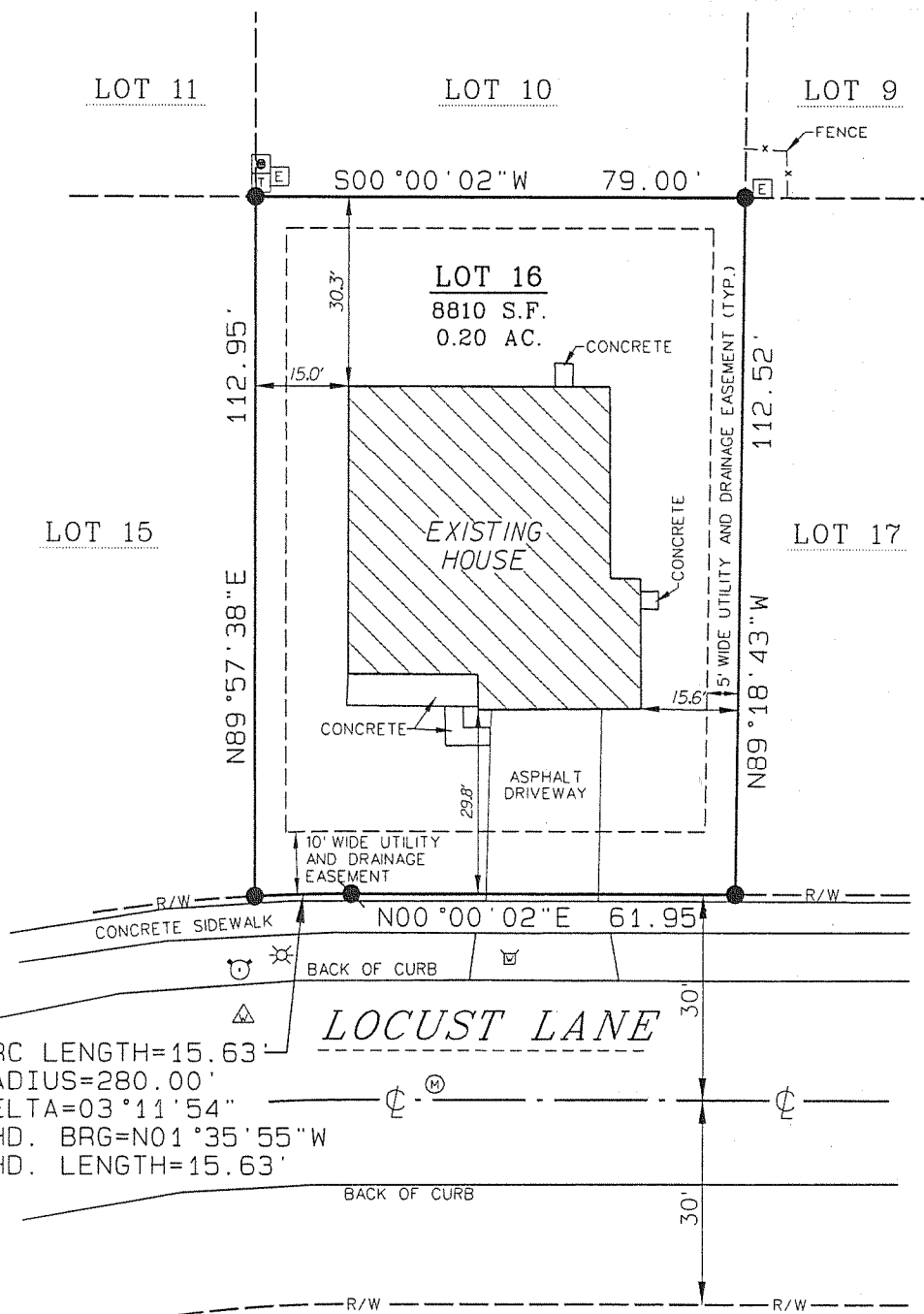


PLAT OF SURVEY

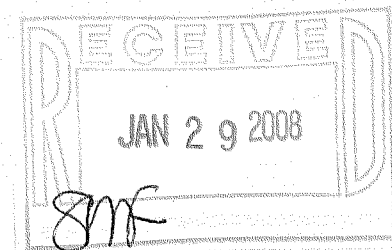

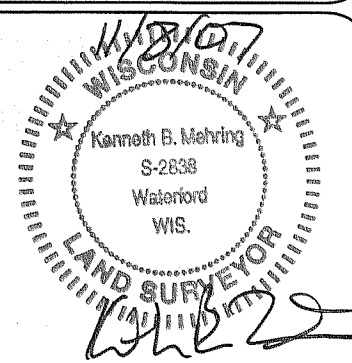
