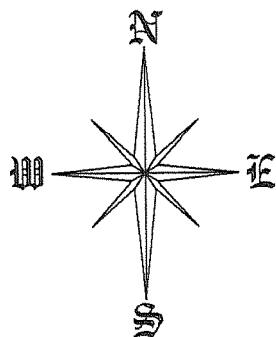


PLAT OF SURVEY

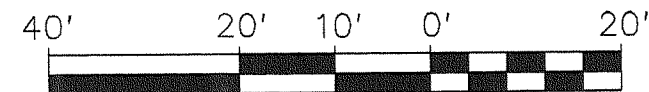


BEARINGS ARE REFERENCED TO THE WEST

extension of East-West lines of said adjoining lands:

and South and 3 1/2 rods wide East and West immediately West of and adjoining the

Wisconsin.

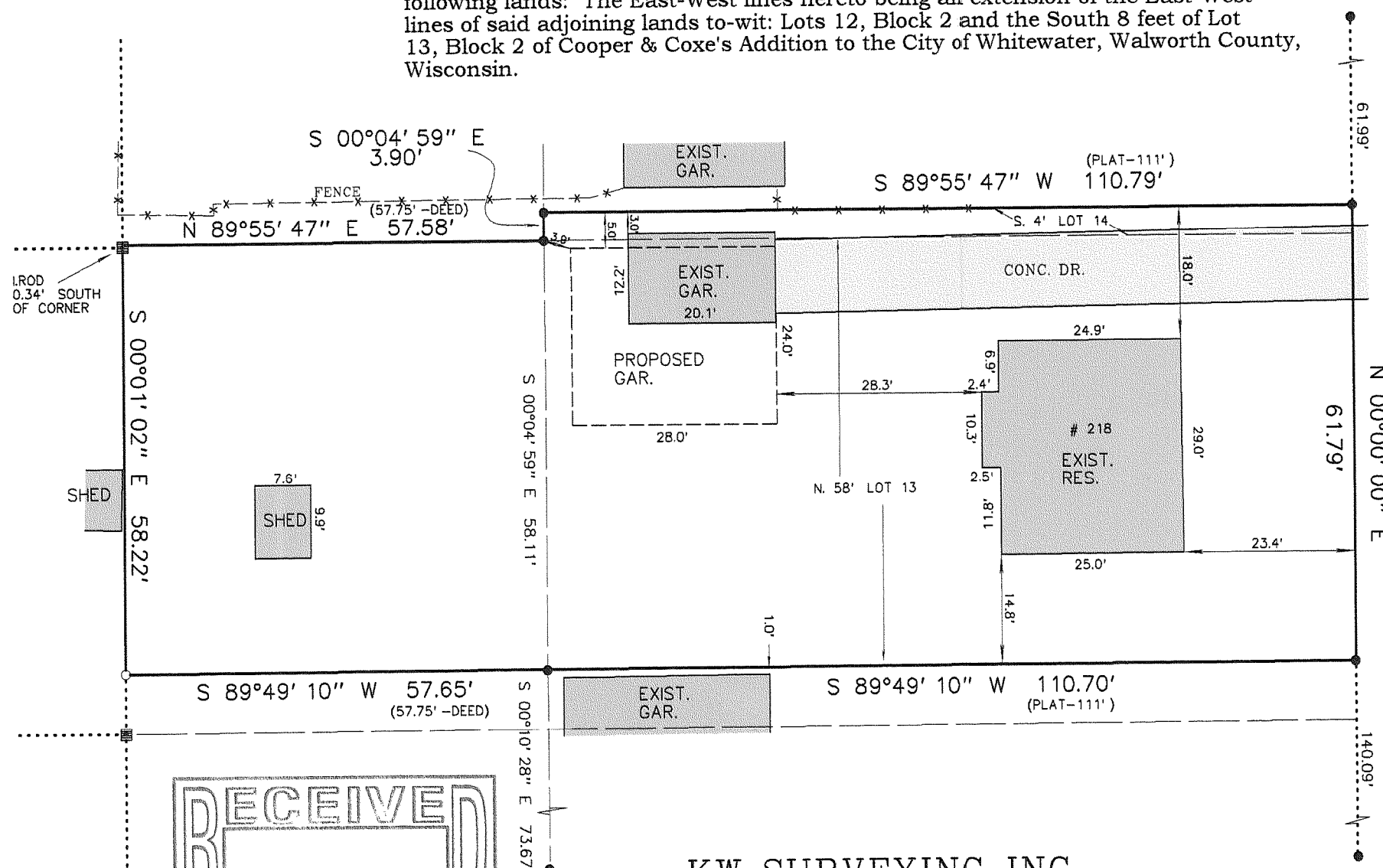

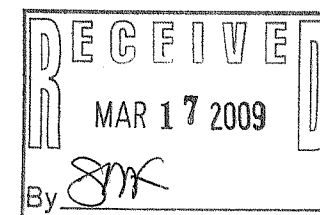
■ - INDICATES IRON ROD FOUND

NORTH FRANKLIN STREET



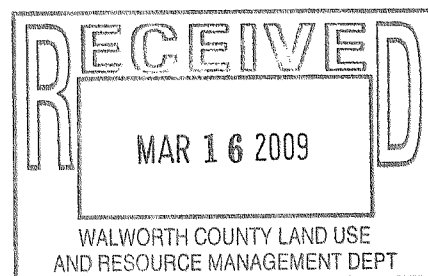
