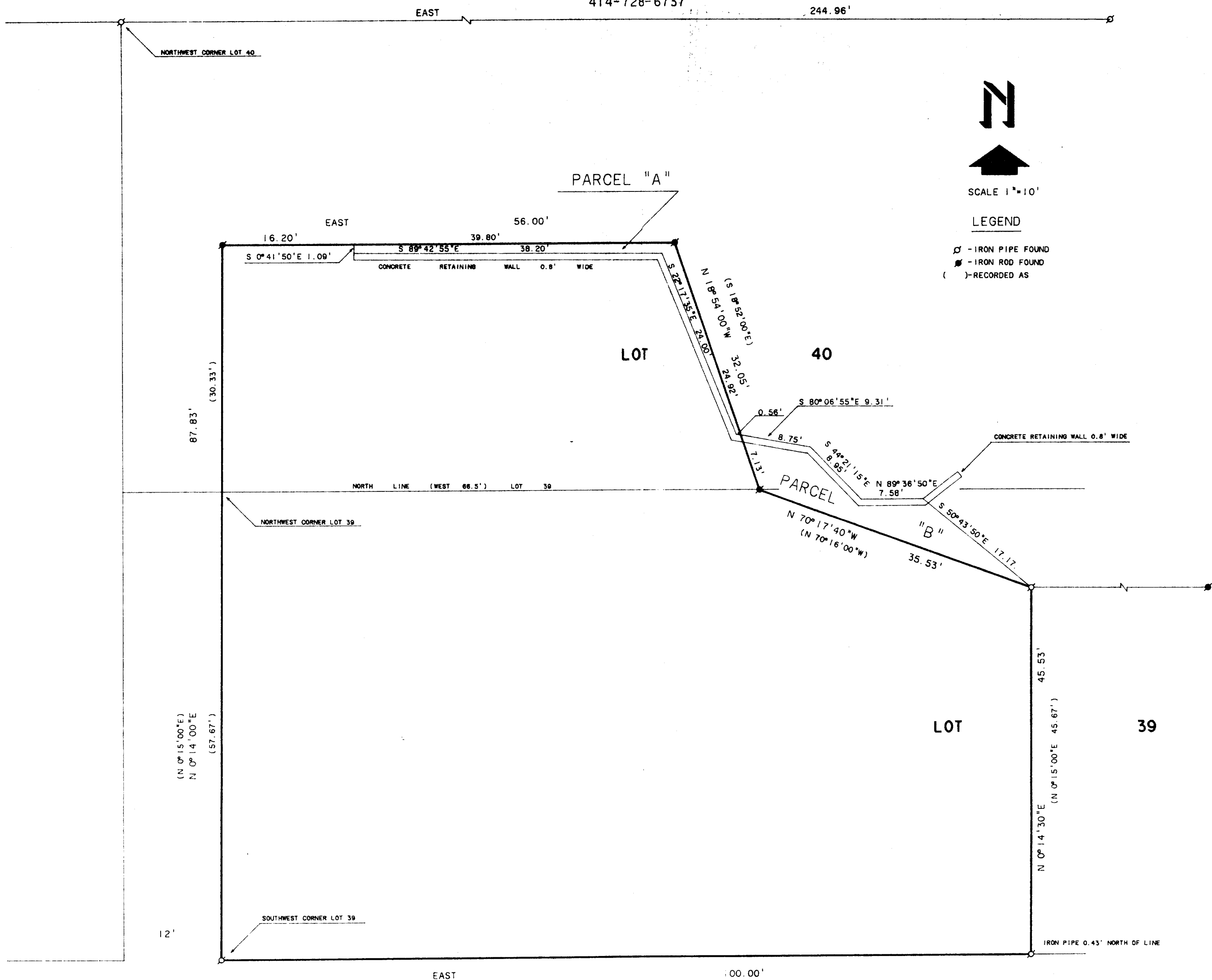

PART OF LOT 40 OF LOCH VISTA CLUB SUBDIVISION NO. 1, LOCATED IN THE VILLAGE OF WILLIAMS BAY, WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHWEST CORNER OF LOT 39 OF SAID LOCH VISTA CLUB SUBDIVISION NO. 1; THENCE N 0°14'00"E 87.83 FEET ALONG THE WEST LINE OF SAID LOT 39 EXTENDED NORTH; THENCE EAST 16.20 FEET TO THE PLACE OF BEGINNING; THENCE S 0°41'50"E 1.09 FEET TO THE NORTH FACE OF A CONCRETE RETAINING WALL; THENCE S 89°42'55"E 38.20 FEET ALONG THE NORTH FACE OF SAID RETAINING WALL; THENCE S 22°17'35"E 24.00 FEET ALONG THE NORTHERLY FACE OF SAID RETAINING WALL; THENCE S 80°06'55"E 0.56 FEET ALONG THE NORTH FACE OF SAID RETAINING WALL; THENCE N 18°54'00"W 24.92 FEET; THENCE WEST 39.80 FEET TO THE PLACE OF BEGINNING. AND CONTAINING 75.95 SQ. FT.

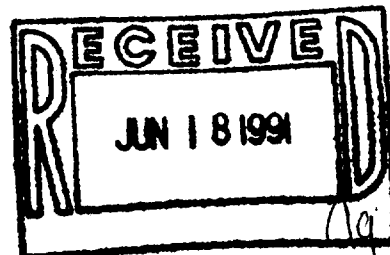

PART OF LOTS 39 AND 40 OF LOCH VISTA CLUB SUBDIVISION NO. 1, LOCATED IN THE VILLAGE OF WILLIAMS BAY, WALWORTH COUNTY, WISCONSIN AND DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHWEST CORNER OF LOT 39 OF SAID LOCH VISTA CLUB SUBDIVISION NO. 1; THENCE N 0°14'00"E 87.83 FEET ALONG THE WEST LINE OF SAID LOT 39 EXTENDED NORTH; THENCE EAST 56.00 FEET; THENCE S 18°54'00"E 32.05 FEET TO THE PLACE OF BEGINNING; THENCE N 18°54'00"W 7.13 FEET TO THE NORTH FACE OF A CONCRETE RETAINING WALL; THENCE S 80°06'55"E 8.75 FEET ALONG THE NORTH FACE OF SAID RETAINING WALL; THENCE S 44°21'15"E 8.95 FEET ALONG THE NORTH FACE OF SAID RETAINING WALL; THENCE N 89°36'50"E 7.58 FEET ALONG THE NORTH FACE OF SAID RETAINING WALL; THENCE S 50°43'50"E 17.17 FEET; THENCE N 70°17'40"W 35.53 FEET TO THE PLACE OF BEGINNING. AND CONTAINING 161.34 SQ. FT.
