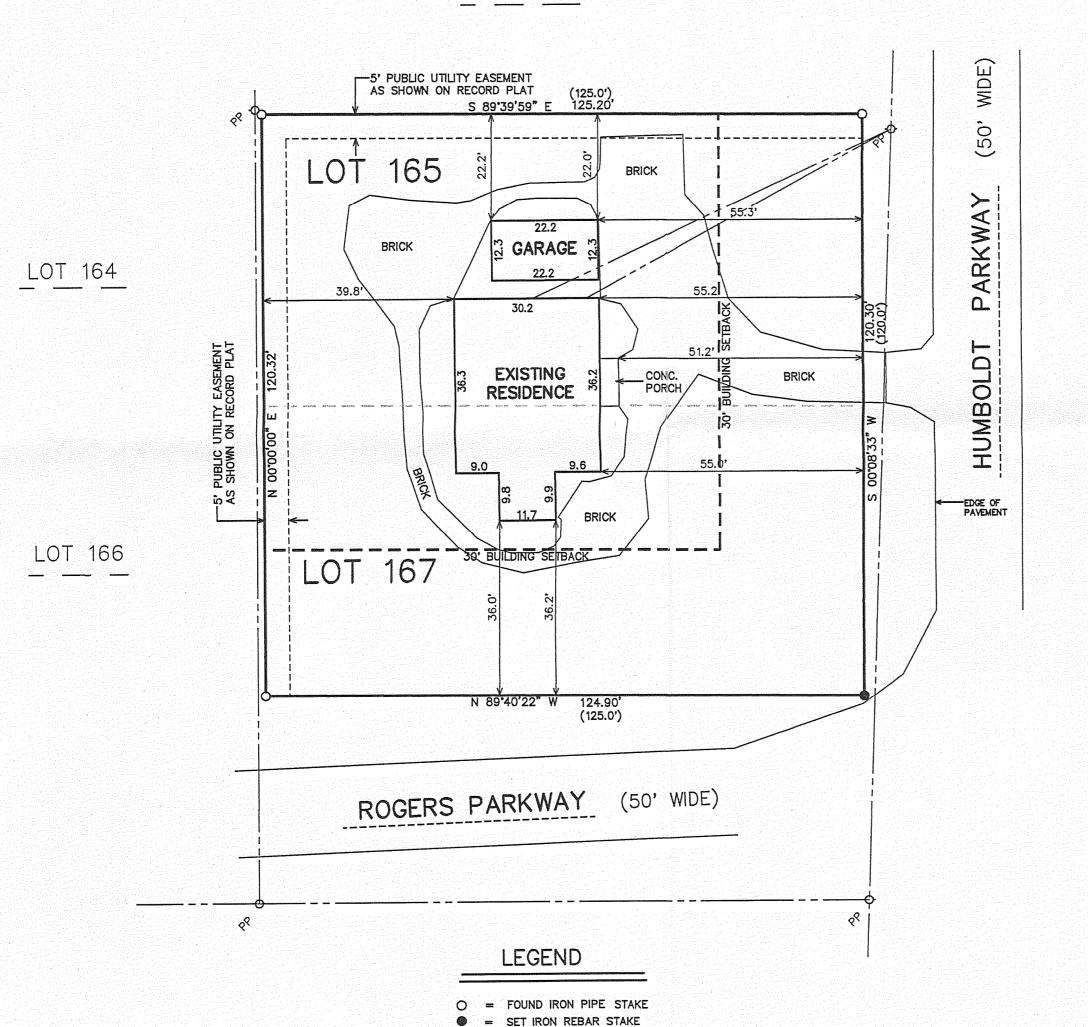

WATERMAIN EASEMENT DESCRIBED IN VOL. 237 OF DEEDS ON PG. 161 GRANTS THE CEDAR POINT PARK ASSOCIATION AN EASEMENT FOR THE INSTALLATION AND MAINTENANCE OF WATERMAIN OVER "...ALL PARKS, COMMUNITY PARKS OR PRIVATE PARKS, INCLUDING THE LARGE PARKS AND PLAZAS FRONTING UPON THE LAKE, THREE OF WHICH ARE DESIGNATED AS "OAK GROVE," "BIRCH GROVE," AND "WALNUT GROVE," AND ALL OTHER PARCELS OF GROUND WHICH ARE SO DESIGNATED ON THE PLAT, TOGETHER WITH ALL DESIGNATED PATHWAYS TO SAID PARKS; ALL PARKING SPACES, WHICH ARE DESIGNATED ON THE PLAT AS SUCH BY THE LETTERS P.S. AND ALL ALLEYS; LOT 229 OF THE ORIGINAL PLAT, WHICH IS DESIGNATED AS WATER TANK; ALSO SPACE DESIGNATED AS P.S. LYING IMMEDIATELY WEST OF LOTS 48 AND 49 OF THE FIRST ADDITION; AND LOTS 113, 114, AND 115 OF THE ORIGINAL PLAT OF CEDAR POINT PARK, WHICH THEREON DESIGNATED AS TENNIS COURTS."
