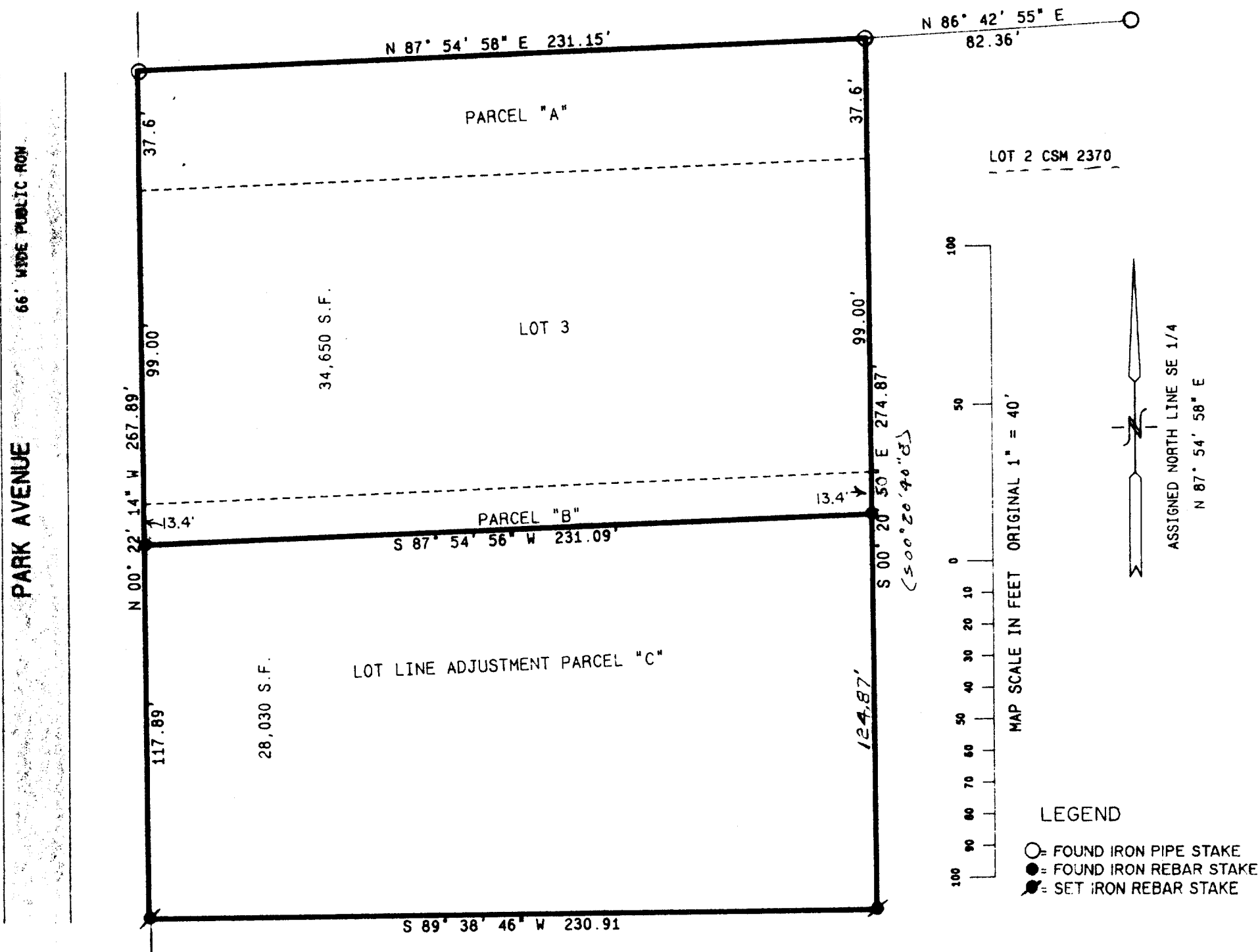

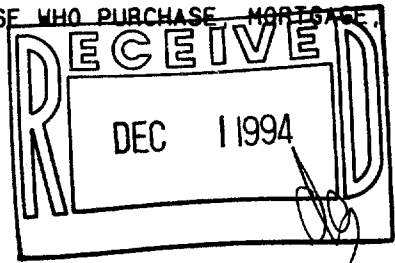
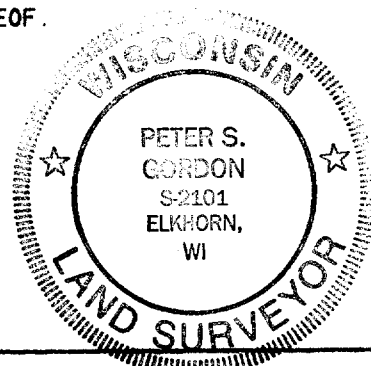
LOT 3 OF SHARON LAND IMPROVEMENT COMPANY'S ADDITION TO THE VILLAGE.

 PARCEL "B": THE NORTH 13.4 FEET OF LOT 4 OF SAID SHARON LAND IMPROVEMENT COMPANY'S ADDITION
